7.	Date and hour for scrutiny and counting of votes, if any	<u>05-02-2015</u> Thursday	12.30 p.m. onwards

Only persons whose names are on the electoral roll of members of the Senate published by the University on **07-11-2014** are eligible to take part in the election and to vote thereat subject to the provisions contained in the Kerala University Election Statutes. Copies of the Electoral roll are available for sale in the University Office on payment of Rs.30/- per copy.

Nominations duly filled in, in all respects shall reach the **Registrar/Returning Officer** not later than **2.00 p.m. on 22-01-2015**. Nominations, if sent by post should be enclosed in an envelope superscribed "**Nomination for election to the Syndicate**".

The polling of votes for the above election will be held from **10.00 A.M. to 12.00 noon on 05-02-2015** at the meeting of the Senate specially convened for the purpose at the Senate Chamber, University Buildings, Thiruvananthapuram.

The Change of transaction of business for the election has been necessitated due to the reasons mentioned in paper read as (2) above. Therefore the content of earlier University notification read as 1 above stands modified to this extent.
