ORDER

The Government of Kerala vide paper read as (1) above, sanctioned a total amount of Rs.24.60 Crore against Annual Plan proposals of the University. The Special Standing Committee of the Syndicate on Planning and Development vide paper read as (2) above, considered the proposal submitted by the Head, Department of Psychology under the scheme 'Starting of New Courses' and recommended to approve the proposal to start 'Post Graduate Diploma Course in Geriatric Counselling' at the Department of Psychology and provided an amount of Rs.2,00,000/-(Rupees Two Lakhs only) as financial assistance for implementation of the Course. The Syndicate vide paper read as (3) above resolved to agree to the above recommendation.

The Standing Committee of the Syndicate on Academics and Research vide paper read as (4) above recommended to start 'Post Graduate Diploma Course in Geriatric Counselling' at Department of Psychology and the Syndicate vide paper read as (5) above, resolved to agree to the above recommendation. The scheme and syllabus of the course has been approved by the Vice-Chancellor, vide paper read as (6) above, subject to reporting to the Academic Council.

Sanction has therefore been accorded by the Vice-Chancellor, to start 'Post Graduate Diploma Course in Geriatric Counselling' at the Department of Psychology with an intake of 40 students from the academic year 2017-18 onwards. The duration of the Course shall be for twelve months with a Course fee of Rs.10, 000/-(Rupees Ten Thousand only) per student.
