CONCEPT NOTE

The Dept. of German, University of Kerala welcomes everyone to this grand event of academic discourse in which scholars from India and Germany will enlighten the sessions with illuminating and illustrious perspectives and reflections.

The Co-founder of ASLE Cheryl Glotfelty writes, "ecocriticism is the study of the relationship between literature and the physical environment". What is then ecocriticism? Simply put, ecocriticism is the study of the relationship between literature and the physical environment. The word 'Ökologie' (Ecology) was first defined by nineteenth-century German Zoologist Ernst Haeckel as "the whole science of the relationships between the organism and its environment". Ecocriticism as it emerged in the 1990s was analogously defined in the first major ecocritical volume, *The Ecocriticism Reader*, as the "study of the relationship between literature and the physical environment," advocating an "earth-centered approach to literary studies". The first phase of ecocriticism in the early 1990s therefore involved a preference for nonfictional genres of nature writing, romantic nature poetry, and wilderness narratives. The Eco-critical movements were significantly shaped and theoretically underpinned by such landmark studies as Lawrence Buell's *The Environmental Imagination*, which rehabilitated the referential and representational dimension of textuality that, in Buell's view, had been unduly neglected in poststructuralist theories. William Rueckert delineates ecocriticism as "the application of ecology and ecological concepts to the study of literature, because ecology has the greatest relevance to the present and future of the world". In this context, the possible plausible relations between literature and nature will be examined in the literary works of German and India in terms of ecological concepts. Ecocriticism, then, attempts to find a common ground between the human and the non-human to show how they can coexist in various ways, because the environmental issues have become an integral part of our existence. Serpil Oppermann delineates Eco-criticism as a site at which material-discursive practices are invested with post-anthropocentric meanings, and it is both transdisciplinary and transnational in its relations with literatures, cultures, and local-global ecological issues, and it emphasizes a strong sense of responsibility towards the planet. Konrad von Megenberg (1309-1374) had imparted the knowledge of natural world in his book *'Buch der Natur'*, and it gives a picturesque impression of relationship of man with other external world in the German medieval period. From Theodor Adorno to Gernot Böhmes *'Atmosphäre'* shall be discussed in the event and it may illuminate the participant with the ecological perspective, and as a whole it may change the attitude towards our 'Mother Nature'.
