ORDER

The Syndicate vide paper read as (1) above resolved to issue applications for affiliation of new colleges/new courses/additional batch/permanent enhancement of seats for the academic year 2020–'21. Thereafter, the Syndicate vide paper read as (2) above, considered the applications received for the academic years 2018–'19 and 2019–'20, the processing of which were delayed owing to the then ongoing academic audit, and resolved to authorize the Standing Committee of the Syndicate on Affiliation of Colleges to consider the unprocessed applications received for the academic year 2019–'20, and further resolved not to consider the applications for affiliation of new courses/ permanent enhancement of seats/ additional batches received for the year 2018–'19 as the validity of the said applications had expired.

Vide paper read as (3), the applications for affiliation of new colleges/new

courses/additional batch/permanent enhancement of seats for the academic year 2020-'21 were invited.

The Syndicate vide papers read as (4) considered the applications for 2019–'20 & 2020–'21 and resolved to conduct Local Enquiry in the colleges by nominated teams for applications received for 2019–'20, and for applications for permanent enhancement of seats and additional batches received for 2020–'21. However, no decision was taken for nominating the teams to conduct inspection on the applications for new courses for 2020–'21. Therefore, only the list of nominated teams to conduct Local Enquiry in colleges in respect of applications for affiliation of new courses for 2020–'21 were approved by the Vice-Chancellor, and the same was reported to the Syndicate vide reference (5) above.

Again, vide reference (6) above, the inspection teams to conduct Local Enquiry in colleges were reconstituted and Local Enquiry was conducted in colleges. Vide paper read as (7), the Syndicate considered the Reports of Local Enquiry and resolved to seek the views of Government wherever the Syndicate considered the application positively.

The Government vide orders read as (8) & (9) above accorded Administrative Sanction to start new courses, to increase seat strength and to allow additional batches of existing courses in colleges. The Syndicate vide paper read as (11), considered the Government orders and the reports of final inspection conducted by teams constituted vide paper (10) and resolved to sanction the following in colleges subject to the fulfillment of procedural formalities of affiliation.

The Educational Agencies of all the colleges mentioned in the above tables have fulfilled the procedural formalities as prescribed by the University.

Sanction has therefore been accorded by the University to grant Affiliation under Statute 12 in Chapter 24 of the Kerala University First Statutes 1977, to new courses, permanent enhancement of seats in existing programmes and additional batches to existing courses with intake mentioned against each in the above mentioned Colleges for the academic year 2020—'21.

The Affiliation granted is provisional and subject to the following conditions:

- 1. The admissions shall be made in accordance with the statutory regulations of the University and the State Government from time to time.
- 2. The management of the Institution shall not close the Institution or the institution shall not discontinue instruction in any course(s) or start any new course(s) or alter intake capacity of seats without the prior approval of the University.
- 3. No excess admission shall be made by the Institution over and above the approved intake under any circumstances.
- 4. The Institution shall not conduct any course(s) in the same premises / campus and / or in the name of the Institution without prior permission / approval of University.
- 5. No capitation fee shall be charged from the students / guardians of students in any form.
- 6. There shall not be any additional financial commitment on the part of the Government and the University.
- 7. The Self-financing Un-aided Colleges shall have to pay the Infrastructure Development and Maintenance fee before 31st March every year, in advance, as prescribed in the Ordinance, to provide service to these Course(s) as they are affiliated on condition that there will not be any additional financial commitment on the part of the Government / University.
- 8. All infrastructural and instructional facilities for higher semesters shall be made available in time to ensure the quality of education provided.
- 9. The period of affiliation shall be one year/ till further orders by the University.
- 10. Further, the institution shall strictly follow all the provisions contained in the Kerala University Act, 1974, the statutes framed there under, and the regulations prescribed by the

Central Regulatory Bodies viz., UGC, NCTE, AICTE, BCI etc. Any violation of the above shall call for liability upon the Educational Agency.

Orders are issued accordingly.
