## ORDER

The University had issued orders implementing the GO (Ms)96/2021/HEDN dated 15.02.2021 in the University and all affiliated Private Aided Colleges, vide paper read as(1)

The Government had issued G.O. No. 242/2022/HEDN dated 18.05.2022 and GO No.279/2022/HEDN dated 05.06.2022 in continuation with GO (Ms)96/2021/HEdn dated 15.02.2021. The G.O. No. 242/2022/HEDN dated 18.05.2022 stipulates the guidelines to be followed in granting reservation to the differently abled candidates in the appointment in Aided Colleges and as per the GO No.279/2022/HEDN dated 05.06.2022, all appointments made after 18.05.2022 shall be made only in accordance with the GO No.242/2022/HEDN dated 18.05.2022.

The Syndicate at its meeting held on 07.07.2022 considered the Government Orders read as (4) and (5) above, along with the recommendations of the Standing Committee of the Syndicate on Teaching and Non-Teaching Staff of Private Colleges vide read as (2) above and resolved to implement the same in the University.

As per the said GO read as paper (4) above, the Universities concerned shall determine the backlog vacancies in the teaching posts in Aided Arts & Science colleges based on rotation since 07.02.1996. For the above purpose all the Educational Agencies of all Aided Colleges shall submit the details of the appointment of Lectures/Assistant Professors made under their Colleges affiliated to University of Kerala from 07.02.1996 to 18.04.2017 and from 19.04.2017 to 18.05.2022 for calculating the backlog vacancies as per GO dated 18.05.2022. They shall also submit the roster for prospective vacancy which will be verified

by the University before providing panels of experts and nominees the initial appointment of Assistant Professors in the respective Colleges.

All appointments made in the Private Aided Colleges after 18.05.2022 shall be made only in accordance with the GO No.242/2022/HEDN dated 18.05. 2022. The Educational Agencies shall furnish a certificate to the University to the above effect while forwarding the proposal for the approval of the appointment of the Assistant Professor under their Colleges.

Sanction has therefore been accorded by the Vice Chancellor to implement the G.O. No. 242/2022/HEDN dated 18.05.2022 and GO No.279/2022/HEDN dated 05.06.2022 mutatis mutandis in the University.

Orders are issued accordingly.
