ORDER

Failed candidates of B.A/B.Sc/B.Com(Annual Scheme) have requested to grant Mercy Chances to enable them to clear the failed papers.

As per the Uniform Span period prescribed by UGC, and implemented vide paper read as(2) above, the maximum duration for completing a programme of study under Annual Scheme is restricted to Y+2 years where 'Y' stands for the normal or minimum duration prescribed for completion of the programme. Since the Uniform Span period is applicable from 2016-2017 admission onwards, the candidates of B.A/B.Sc/B.Com under Annual Scheme of 2016 admissions are eligible to appear mercy chance examinations only, if any granted, remitting the respective fee whereas the candidates prior to 2016 admissions can avail all the supplementary exam notified from time to time, remitting normal exam fee.

The Syndicate considered the matter and resolved vide paper read as (3) above, to approve the recommendation of the Standing Committee of the Syndicate on Examinations held on 24/03/2023, to refer the matter to the Standing Committee of the Syndicate on Finance.

The Standing Committee of the Syndicate on Finance at its meeting held on 08/05/2023, recommended to impose the mercy chance examination fee for all the failed candidates of B.A/B.Sc/B.Com Annual Scheme prior to 2016 admissions. The Syndicate, vide paper read as (4) above, resolved to approve the same.

The Standing Committee of the Syndicate at its meeting held on 21.09.2023 after considering the above resolution of the Syndicate, recommended the following, subject to reporting to the Academic Council.

- To restrict the B.A/B.Sc/B.Com(Annual Scheme) candidates prior to 2016 admission from appearing supplementary examinations and they are eligible only for mercy chance examination, if any granted.
- To grant one mercy chance examination to the failed candidates of B.A/B.Sc/B.Com(Annual Scheme) candidates prior to 2016 admission and 2016 admission onwards in the existing scheme and syllabus whose permissible chance now stands expired.

The Syndicate, vide paper read as (5) above, approved the same.

Sanction has therefore been accorded by the Vice-Chancellor to implement the above resolution of the Syndicate, subject to reporting to the Academic Council.

Orders are issued accordingly.
