ORDER

Private Registration for the academic year 2022-23 has been granted, vide UO read as paper (1) above, as per the resolution of the Syndicate at its meeting held on 29.12.2022, to issue notification for the continuance of Private Registration in the University for the academic year 2022-23 as done in the previous year.

The matter of continuance of private registration for 2023-24 has been considered and the Syndicate at its meeting held on 27.06.2023, vide paper read as (2) above, resolved to seek opinion of the Government. Accordingly opinion was sought from the Principal Secretary to Government, vide paper read as (3) above.

The Syndicate at its meeting held on 24.08.2023 considered the matter again and resolved, vide paper read as (4) above, to issue notification for Private Registration for the Academic year 2023-24 after obtaining the opinion of the Government. Accordingly opinion of the Government was sought again in the matter, vide paper read as (5) above.

In response to the letters seeking opinion of the Government, the Principal Secretary to Government, vide paper read as (6) above, has informed that status quo be continued with regard to private registration.

Sanction has therefore been accorded by the Vice-Chancellor, to issue notification for the continuance of Private Registration in the University for the academic year 2023-24 as done in the previous year, based on the opinion of the Government to maintain the status quo with regard to the Private registration.
