**ORDER**

The Guidelines for improvement of internal marks has been implemented vide U.O. read (1) above to students of B.Tech/B.Arch Degree Courses who have secured 40 or above marks in theory examination,

Sri. Karun. M.B who had appeared for 7<sup>th</sup> semester B.Tech Degree Examination scored 35/50 as Sessional marks and 64/150 as University marks (ESA marks) for the paper 13.702 Design and Drawing of Reinforced Concrete Structures and declared failed with a total mark of 99/200 has requested to consider him for One time sessional improvement as he is in need of at least 36 marks for internal assessment to secure a pass.

The Chairperson, BoS in Engineering (Pass-I) vide paper read (3) above has opined that the student can be permitted to improve sessionals. The Dean, Faculty of Engineering and Technology endorsed the Chairperson's recommendation to permit a sessional improvement for this candidate. Also recommended to make suitable amendments to increase the maximum permitted improved Sessional marks to 40 out of 50.

The Academic Council vide paper read as (4) above considered the matter and resolved to approve the proposal by the Chairman Board of Studies and Dean.

Hence the Clause 2 of the U.O. (1) read above is amended as "The B.Tech students (Candidates of 2008 and 2013 Scheme) who have completed five years after joining the Course and B.Arch students of 2008 Scheme who have completed six years of joining the Course and obtained 40 marks or above in University theory supplementary examination and failed in the subject due to low internal assessment marks (less than 35 and less than 40 for the subjects, 13.702. Design and Drawing of Reinforced Concrete Structures and 13.802- Design and Drawing of Steel structures of the Civil Engineering branch) alone are eligible to apply".

U.O. read (1) above stands modified to that extent.
