ORDER

An Expert Committee to study and submit report for Modernization of Administration of the University was constituted, vide paper read as (1) above and the Committee submitted a detailed report .

The Syndicate, vide paper read as (2) above considered the report submitted by the Committee. Further, the report was placed before the sub committee and discussions were held with the representatives of the organizations of the University employees. The final proposal thus prepared, after detailed discussions & deliberations, was considered by the Syndicate, vide paper read as (3) above and resolved to approve the proposal for reallocation of works among Administrative sections.

The Senate, vide paper read as (4) above considered and approved the said proposal.

The Administrative Reforms Committee, at its meetings held on 14.07.2022 & 29.08.2022 recommended to finalize the reallocation of works among Administrative sections.
