ORDER

As per the recommendations of the University Level Committee, constituted to monitor the functioning of Autonomous Colleges an University order read as (4) was issued stating that

1. Migration Certificate may be issued to the students belonging to 2014-'15 PG admission who have completed the course of study in the autonomous colleges subject to granting of Matriculation and Recognition by the University levying the fees at the existing rates. University Order No.M&C.I.2/1735/2015 dtd 7.09.2015 issued in this regard shall be complied with for the 2014-'15 PG batch.
2. The Migration Certificate of the UG students of 2014-'15 batch and UG ,PG students of 2015-'16 admission onwards shall be issued only after finalizing the norms regarding the Matriculation, Recognition, QC Verification and fees to be levied for the said purposes. The norms for issuance of migration certificate to the students of Autonomous Colleges affiliated to the University has not been finalized so far.

Sanction has therefore been accorded by the Hon'ble Vice Chancellor to follow the directions contained in the U.O read as (3) above that the existing rules with regard to the issuance of migration certificate from the University be observed in the case of students from autonomous stream of courses in the autonomous colleges affiliated to the University also, from the academic year 2014-15 onwards. It is further clarified as contemplated in the said U.O that the Principal/Competent authority of autonomous college be authorized to forward verification report duly endorsed (Application/Extract of Marks/Memo for Cancellation of course/examination etc.) in respect of the students from autonomous stream of courses from academic year 2014-15 onwards exclusively for the purpose of obtaining migration certificate from the University. This U.O shall stand valid till the norms with respect to the Academic and Examination related matters of the Autonomous Colleges are finalized by the Syndicate.

The U.O read as (4) above stands modified to this extent. Orders are issued accordingly.
