ORDER

As per the existing guidelines, Grace marks shall be awarded to the candidate on the basis of his/her performance in the respective academic year. The student shall claim the Grace Marks within one year after completion of the course but prior to the issue of Degree Certificates.

While considering the matter of granting permission to students who were eligible for grace marks and were unable to apply for the same due to Covid-19 restrictions, the Standing Committee of the Syndicate on Examinations held on 29.10.2021 vide Item No.01, has recommended that the time for claiming grace marks in respect of 2016-17, 2017-18 & 2018-19(PG only) admission students in the UG under CBCS System, PG and Professional Courses be extended upto 31.12.2021 in the wake of Covid-19 pandemic.

Sanction has therefore been accorded by the Vice-Chancellor, subject to reporting to the Syndicate, to extend the time for claiming grace marks in respect of 2016-17, 2017-18 & 2018-19(PG only) admission students in the UG under CBCS System, PG and Professional Courses be relaxed upto 31.12.2021 in the wake of Covid-19 pandemic.
