**ORDER**

The Syndicate vide reference cited (2) above considered the matter regarding imposing penalty in th event of erroneous examination registration along with the recommendations of the Combined meeting of the Standing Committees of the Syndicate on Examinations and Finance, vide reference cited (1) above, and resolved to impose a penalty as follows in the event of erroneous examination registration by the affiliated colleges who are reluctant to adhere to:

<i>Sl No</i>	<i>Nature of Mistakes</i>	<i>Penalty to be imposed</i>
1	Subject Correction - In case of Exam Registration by College	Rs.100/- per candidate
2	Exam Registration - By students and not forwarded to University	Rs.100/- per candidate
3	Enrollment - Second Language correction	Rs.100/- per candidate
4	Enrollment - Elective correction for B.com	Rs.100/- per candidate
5	CA mark - Wrong Entry by College	Rs.100/- per candidate
6	Semester Registration - Wrong/Non Assigning faculty members by HOD	Rs.500/- per subject

The Syndicate further resolved to grant 10 days to the College authorities for verifying and rectifying the errors, after the last date of examination registration and to implement the above proposal for imposing penalty in the event of erroneous examination registration if the same is not rectified within the grace period.

Sanction has therefore been accorded by the Vice Chancellor to implement the above resolution of the Syndicate.

The Finance, vide paper read as (3) above, has endorsed the same.

The penalty shall be applicable for the notification of examinations on or after the date of issuance of this order.

Orders are issued accordingly.
