Whereas the University of Kerala has notified as per notification read as (1) above, the election of 12 members to the Syndicate from among the members of the Senate, as provided under section 21 Other members (a) of the Kerala University Act, 1974 and; whereas only one nomination each have been filed for the following categories; under item 21 Other members (a) (i) one shall be a person belonging to a scheduled caste/scheduled tribe, (ii) one shall be a Principal of a Government College and (iii) one shall be a University teacher who is not a Principal; vide notification read as (2) above and as the number of candidates validly nominated and not withdrawn does not exceed the number of vacancies to be filled by election, it is hereby notified under Statutes 33 and 41 of the Kerala University (Conduct of Elections to various Authorities or Bodies) first Statutes, 1974, that the following persons have been duly elected unopposed to the Syndicate, from among the members of the Senate.

1. One shall be a person belonging to a scheduled caste/scheduled tribe; 21 -Other members (a) (i) of the Kerala University Act, 1974.
