

**RULES FOR THE AWARD OF UNIVERSITY MERIT SCHOLARSHIPS FOR
THE 3 YEAR BA/BSc/BCom DEGREE COURSES
(Revised as per the decision of the Meeting of the Syndicate
held on 29/03/2012)**

1. There shall be **One hundred and Eighty Eight (188)** Merit Scholarships of the value of **Rs.2,500/- (Rupees Two thousand and Five hundred only)** each per annum.
2. The subjectwise distribution of the scholarships shall be as follows:

3. These Scholarships shall be awarded annually by the Syndicate on the basis of the merit as judged by the percentage of total marks secured by the students at the HSE/VHSE/CBSE/ISC Examination held immediately before the date of their admission to the College.
4. The Scholarships are tenable for a period of three years.

5. The Scholarships shall be awarded only to students who pass the HSE/VHSE/CBSE/ISC examination at the first attempt and who secure not less than 55% of marks at the HSE/VHSE/CBSE/ISC Examination.
6. If a Scholarship awarded to one student falls vacant, the vacant Scholarships shall be awarded to the candidate next in rank in the subject concerned as per rules.
7. In the event of there being no candidate eligible for the award in any one or more subjects in a year, the award of such Scholarship shall be re-allotted by the Syndicate to another subject for that year.
8. All the candidates having the same marks at the +2 level examination shall be considered for the Scholarship irrespective of their performance at the X level examination.
9. The Principals of Colleges shall be the drawing officers for the disbursement of the above scholarships. The annual value of the Scholarships shall be paid on a quarterly basis in advance to the Principals concerned. The Principal shall forward to this Office the payee's receipt for the first quarter along with the bills for the second quarter and so on. The bills for the four quarters shall be forwarded by the Principals and payments made to them by the University in the months of June, September, December and March every year. The Principals shall retain the amount with them and make payments in arrears to the students at the close of each month. It shall be the responsibility of the Principals to see that the disbursements are made strictly in accordance with the rules. Any unspent balance left with the Principals at the end of each quarter shall be remitted to the Kerala University Fund.
10. Students who belong to the Kerala State and are studying in any of the Colleges affiliated to the University of Kerala immediately after passing the qualifying examination are eligible for the awards.
11. The Scholarships shall not be held concurrently with any other scholarships except welfare scholarships offered by State/Central Government. The continuance of the Scholarships for each year shall

depend upon the satisfactory progress and conduct of the holders thereof.

12. The Scholarships shall not be held for more than one year in the same class and shall be discontinued in the event of failure at any University Examinations.
13. The Scholarships may be held along with fee concessions, if any, enjoyed by the holders.
14. Any change in these Rules shall be made by the Syndicate.
