Item No.15.09. University Health Centre - Engaging Resident Medical Officer on contract basis - Fixing of remuneration-Consideration of - reg.

(Ad.DII)

The University Health Centre, has one sanctioned post of Resident Medical Officer. As per the Kerala University First Ordinances, 1978 the qualification of RMO should be MBBS from a recognised University and permanent registration with the Travancore/Cochin/Kerala Medical Council. At present the post is filled on contract basis with a monthly remuneration of Rs.40,000/-(Rupees Forty Thousand only).

The Syndicate, held on 13.03.2020, while considering the matter regarding revamping of University Health Centres, vide item no.10.129 had resolved not to give further extension to RMO

currently engaged on contract basis at the Health Centre, Kariavattom and to appoint a new RMO with a monthly remuneration of Rs.1,00,000/- (Rupees One Lakh only). Further, the Syndicate resolved to provide quarters at Kariavattom Campus, free of rent for RMO, as the nature of work is residential. It was also resolved to grant one casual leave per month.

Thus, for implementation of the Syndicate resolution, when the file was forwarded to Finance section for endorsement, the Finance section has pointed out that:

- 1. the consolidated amount fixed for Resident Medical Officer on contract basis at the University seems to be much higher than the remuneration/ wages of government/ contract employees of other institutions. ie, the enhanced rate of remuneration of Rs.1,00,000/- fixed is more than twice the present rate of Rs.40,000/-.
- 2. as per the latest salary enhancement order of contract employees, G.P(p)/112/2018/Fin dated 21/07/2018 the maximum admissible monthly pay for Medical Officer is Rs. 55,825/-.
- the scale of pay stipulated for Medical Officer as per latest pay revision order is Rs.45800-89000. In government, a person appointed as a regular employee draw only an initial pay of Rs. 57360/- after including DA (20%) HRA (Rs.2000) CCA (Rs. 400).
- 4. More over the consolidated monthly pay fixed for Medical Officer in various institutions under Government were also provided for reference:
- 1. BARC Hospital: Residential Medical Officer-Rs.72000/- for first year, Rs.74,000/- for second year and Rs.76000/- for third year.
- 2. National health mission TVM, palliative care Medical Officer-Rs.41,000/- per month.

Hence, the finance has opined that the requirement of the University and criteria taken for fixing a higher pay shall be stated separately in administrative orders so as to avoid audit objections.

Thus, when the same was reported to the Vice-Chancellor, while considering the matter regarding engagement of Resident Medical Officer on contract basis, the Vice-Chancellor has ordered to place the matter before the Syndicate.

Hence the matter regarding the fixing of remuneration of Resident Medical Officer to be engaged on contract basis at University Health Centre is placed before the Syndicate for consideration.

#### Item No.15.22.01 Complaint from Vaishnavi P - First DC literature student at Sree Narayana College, Chempazhanthy - Mental harassment - reputational threat from seniors reg : -

(AcBI)

A complaint was received from Smt.Vaishnavi P, first DC, Literature student at Sree Narayana College, Chempazhanthy regarding the mental harassment from her seniors, face to face and through social media. She requested the Principal, S.N College Chempazhanthy and Internal Complaints Committee (ICC) to look into the matter and it was not accepted. Her family was humiliated in front of the college and ICC in a PTA meeting. In her complaint the student requested the authorities to safeguard her studies since this was her first year in college and also requested to provide a conclusive atmosphere in the college. The Principal Sree Narayana College, Chempazhanthy remarked that the complaint given by Ms.Vaishanavi P was forwarded to the Station

House Officer, Kazhakoottam and the ICC and preliminary enquiry was conducted by the ICC and notice was sent to the concerned students. The Principal has informed that Ms. Vaishnavi withdrew her complaint in writing, the copy of which is attached along with the letter from the Principal.

Meanwhile an e-mail was received from Dr. Swapna Gopinath, Associate Professor in English, S N College Chempazhanthy and Convener of Womens' studies cell and former Convener of ICC. Dr. Swapna Gopinath has put forward several allegations against the Principal S N College Chempazhanthy and states that she compelled Vaishanavi to withdraw the complaint. According to Dr. Swapna Gopinath the statements made by the Principal in the General Body and at the ICC meeting amounted to further harassment to Vaishnavi who was threatened by the respondents to withdraw the complaint.

#### **Recommendation:**

#### Item No.15.22.02 Judgment of the Hon'ble High Court in WP(C) nos 5138, 5095, 5094, 5113, 5108, 5130, 4914, 4905, 5000, 4912, 4913, 4896 of 2020 -Representations submitted by 12 students before the Chairman,Kerala University Union - Hearing by the Board of Adjudication of Students' Grievances (BASG) - reg.

(AcBI)

The Chairman, Kerala University Union vide letter dated 07.02.2020 has forwarded representations addressed to the Chairman, Board for Adjudication of Students Grievances for the conduct of BASG for 12 students (11 from University College and 1 from Sanskrit College) who were under suspension for 4 months in connection with the University college issue. It has been pointed out that the students are studying in different semesters for different courses and the continued delay in conducting an enquiry and not granting the petitioners a chance to prove their innocence will affect the future prospects of the petitioners. Further it has been submitted that they have played no part in the ill fated events which took place in University College on 12. 07. 2019 (stabbing issue of Akhil). Unfortunately the victim, the person who is alleged to be stabbed and the petitioners belong to the same student organization. It has been alleged that, action was taken not only against the perpetrators of the incident, but also against innocent bystanders like the petitioners. The petitioners have not been able to attend the University Examinations. The petitioners have requested the BASG to invoke powers vested under Chapter 36 of Kerala University First Statutes, 1977 and start enquiry in these illegal suspensions.

Meanwhile, the petitioners filed writ petitions before the Hon'ble High Court in which the Hon'ble Court in its judgements dated 20.02.2020 and 24.02.2020 directed the BASG, to take up, consider and pass appropriate orders on the representations submitted by the petitioners and the petitioners shall be heard before orders are passed as directed.

In this context it may be noted that the happenings in the college that led to the suspension of the students attracted much public and media attention and the Government and the Educational Agency of the College has already initiated action including inquiry by crime branch police and had entrusted law enforcement machinery to ensure peace in the campus.

As per the Kerala University First Statutes 1977, the Principal of the college shall the Head of the College and shall be responsible for the internal management and administration of the college. **Recommendation** 

In deference to the directions of the Hon'ble High Court on various WP(c) s on the issue relating to suspension of students from the University College, Thiruvananthapuram and Government Sanskrit College, Thiruvananthapuram consequent on the clash among students occuring in the University college campus, the BASG heard the Principals concerned and the petitioners individually and obtained their statements.

The individual petitioners submitted that they were not guilty of any misconduct and pleaded that they may be allowed to continue their academic career. The Principals concerned observed that the students should be allowed to complete their academic programmes, but expressed their difficulty in readmitting the students to the same colleges since it may lead to law and order issues. The Committee observed that the petitioners were bound to lose academic years on account of the persisting suspension period, while no specific judgment of any Court of law relating to the issue in question prevails, other than to hear the petitioners in this context and pass appropriate orders. However in view of the pleading by the students and the statements made by the Principals, the Committee made the following recommendations.

1. The eleven students from University College, Thiruvananthapuram be permitted to apply for inter-college transfer to colleges, other than the University College, Thiruvananthapuram and Government Sanskrit College, Thiruvananthapuram, where the concerned subjects of study are offered, in the respective semesters, adhering to regulations, as a special case taking into consideration that the students may not be deprived of their academic career and at the same time considering the serious apprehension expressed by the Principal concerned on the law and order situation if the students are permitted to continue studying in the University College, Thiruvananthapuram.

2. Since Sri.Nazeem.M, Semester 1 BA Sanskrit Vedanta, Government Sanskrit College, Thiruvananthapuram is not eligible for re-admission as per norms, he may be permitted to apply for fresh admission during 2020-21 to any affiliated college under University of Kerala, other than University College, Thiruvananthapuram and Government Sanskrit College, Thiruvananthapuram.

**Resolution of the Syndicate** 

**RESOLVED** that the above recommendation of the meeting of the Board for Adjudication of Students' Grievances held on 03.07.2020, be approved.

#### Item No.15.22.03 Judgment No WP(c) No.34248 of 2019(E) of the Hon'ble High Court of Kerala – Representation from students of Government Law College – reg. (Ac.BI)

The Hon'ble High Court of Kerala in its judgment dated 04.12.2019 in WP(c) No. 32971 of 2019(V) directed the BASG to consider the representation dated 23.112019 submitted by the petitioners (Government Law College students under suspension) to the Vice Chancellor in accordance with law and attain finality to the same at the earliest and at any rate, after providing notice of hearing to all concerned. The BASG at its meeting held on 24.12.2019 considered the above matter and recommended that the Principal be directed to resolve the issue as immediately as possible in consultation with all concerned inorder to ensure that the academic prospects of the petitioners does not suffer and also to take necessary measures to maintain an amiable environment in the institution conducive to academic activities. The Syndicate at its meeting held on 21.01.2020 approved the same.

The decision of the Syndicate was intimated to the Principal, Government Law College vide this office letter dated 27.02.2020. The Principal vide letter dated 23.03.2020 informed that although the consultative meeting was convened on 21.03.2020, the victims their parents and their college level political leaders did not turn up. It has also been informed that one more meeting will be convened at any rate before the college reopens. If the present COVID-2019 situation persists till the commencement of the next academic year, the absentees of the meeting of 21.03.2020 will be given a notice to submit their opinion by writing.

Meanwhile, the petitioners filed a Writ Petition No. WP(c) No.34248 of 2019(E) before the Hon'ble High Court in which the Court has pointed out that the complaint submitted by the petitioners are not considered by the Grievances Cell so far. The Hon'ble High Court has directed the BASG to take up Ext.P6 complaint preferred by the petitioners and to take a decision expeditiously as possible, in accordance with law, within a period of four weeks from the date of receipt of a copy of the judgment(which expires on 29.07.2020).

Recommendation

The Committee heard the Principal of the college who remarked that the college had no objection in revoking the suspension of the 4 students uniformly so that they can continue their academic career in the respective programmes.

The Committee noted that a final decision on the matter can be arrived at, only after conducting a hearing of the petitioner students.

Hence recommended to hear the petitioner students.

#### Recommendation

The Committee heard the petitioner in detail. The petitioner expressed his concern regarding the admission process for Ph.D programme through the concerned Doctoral Committees which appeared to provide ample opportunity for biased decisions by the members of the Doctoral Committee, which are detrimental to the interest of the students and the University at large. He further stated that he did not press any longer on his personal complaint, but sought the University to look into his above mentioned apprehension.

Recommended that the Registrar be authorized to look into the admission process to Ph.D programme to see if there are any flaws or deficiencies. Also recommended that necessary steps may be initiated to make the system more efficient, student friendly and foolproof.

**Resolution of the Syndicate**

# Item No.15.22.05 Admission granted to Sri. Stephin S N, to BA Degree Course in History at VTMNSS College, Dhanuvachapuram who was suspended on ragging case – reg:

#### (Ad.DII)

Complaints have been received from the Secretary, SFI Thiruvananthapuram District Committee and General Secretary, Kerala University Union regarding the admission granted to Sri. Stephin SN to BA Degree Course in History at VTMNSS College, Dhanuvachapuram as the candidate was suspended from the College during the year 2017, in connection with a ragging case.

The Principal VTMNSS College, Dhanuvachapuram was requested to offer remarks in this regard and the Principal submitted the following:

1. Sri. Stephin S N was admitted in the college under PWD quota as per allotment memo issued by University of Kerala on 21/06/2019 to BA Degree Course in History.

2. Previously Sri. Stephin S N was admitted in the academic year 2015-16 in B.Sc Botany under PWD category.

3. During the course of his study he was involved in a ragging case. The act of ragging was first reported to the UGC and the UGC Anti-ragging Cell and it was directed to take strict action in the complaint(ARCC/KL-3368).

4. Accordingly an enquiry committee was constituted at college level. The committee conducted an enquiry and submitted its report in which Sri. Stephin S.N was found guilty.

5. On the recommendation of the College Anti-ragging Committee and College Council, he was suspended from the college with effect from 30.06.2017 as per the letter No.1813/17 dated 30.06.2017, preventing him from attending classes and all academic privileges for the remaining period of his study in the institution, was withdrawn.

6. The matter was reported to the UGC Anti Ragging Cell as well as the University of Kerala.

7. Now he is again admitted under PWD category for BA Degree Course in History at VTMNSS College, Dhanuvachapuram.

The Principal further requested to take appropriate decision in this case at the earliest.

The matter was placed before the Board of Adjudication of Students' Grievances, held on 24.12.2019 and it was recommended to conduct hearing of the Principal and petitioner at the next meeting of the BASG.

#### Recommendation

The Principal of the College and Sri. Riyas Vahab, District Secretary, SFI, Thiruvananthapuram were present for the hearing and they were heard in detail by the Committee. The Principal could not satisfactorily explain as to how the said student who have been issued compulsory TC earlier, ie on 17.12.2018 on ragging charges was once again given admission to the same college for a different programme as the previous TC happened to be a mandatory document for admissions. The Committee noted that as per anti ragging provisions of the UGC, a student cannot be deprived of his academic career for consecutive semesters on account of such charges, depending on the severity of the misconduct.

The Committee expressed its concern on the procedure lapse on the part of the college and recommended that the original TC submitted by the said student for the present admission be examined to see whether there is any foul play. Also recommended that if nothing untoward is found, then the student may be allowed to continue his academic programme in some other college under the same educational agency by way of inter-college transfer adhering to regulations.

tem No.15.23. University Health Centre, Kariavattom - Extension of contract of the existing Resident Medical Officer appointed on contract basis – Consideration of - reg.

(Ad.DII)

The Syndicate held on 13.03.2020, while considering the matter regarding the revamping of University Health centre, vide item no. 10.129, resolved to appoint a new Resident Medical Officer at the University Health Centre, Kariavattom, on completion of the tenure of contract of the current RMO appointed on contract basis.

The tenure of the current RMO, Dr.R.Krishnaprasad expired on 03.04.2020, ie., during the lockdown period and it was decided to permit him to continue in service until a new RMO is appointed. Further, it was decided to give extension to the RMO on contract basis for a further period of 89 days or until a new RMO is appointed. It was also ordered to obtain remarks on the remuneration to be paid to the RMO on contract basis who is to be reengaged for a period of 89 days. The Finance section opined that the RMO may be paid the same remuneration he is currently being paid ie., Rs.40,000/- per month. The file when submitted to the Vice-Chancellor for orders on reengaging the RMO on contract basis for a period of 89 days with a consolidated pay of Rs.40,000/-, it was ordered to place the same before the Syndicate. It may be noted in this regard that if the RMO was to be re-engaged for a period of 89 days, his first tenure would have been completed on 02.07.2020 itself.

Meantime, Dr. R. Krishnaprasad, the current Resident Medical Officer on contract basis, sought clarification on non renewal of his contract till now. He has also informed that he is ready to relinquish his service anytime, but by doing so, deserting the health centre without handing over charge to a responsible Medical Officer will be dereliction of duty as well as violation of Medical Ethics, especially in the current COVID-19 scenario and has requested either to permit him to resign at the earliest without handing over charge of Health Centre to any responsible Medical Officer or to continue till a responsible Medical Officer assumes charge.

Dr. R. Krishnaprasad has also requested to settle his salary from 04.04.2020 onwards and to settle the arrears of salary w.e.f. 27.12.2016 as per the relevant government orders in this regard. It may be noted that the remuneration for contract employees are revived time to time as per existing government norms and currently the RMO is paid a remuneration of Rs.40,000/- as per remuneration enhanced vide U.O No. Ad.AV.6906/ 2019 dated 19.10.2019.

In light of the circumstances explained above the matter regarding **re-engagement of Dr.R.Krishnaprasad, the current Resident Medical Officer on contract basis for a period of 89 days with a consolidated monthly remuneration of Rs.40,000/- or till the appointment of a new Resident Medical Officer, whichever is earlier,** is placed before the Syndicate for consideration and appropriate decision thereof.

#### Resolution of the Syndicate

**RESOLVED** to re-engage Dr.R.Krishnaprasad, the current Resident Medical Officer on contract basis for a period of eleven months with a consolidated monthly remuneration of Rs.40,000/- or till the appointment of a new Resident Medical Officer.

Item No.15.24. Disbursement of salary to contract/contingent employees for the month of July2020 –Consideration of- reg.

#### (Finance)

The usual procedure followed for disbursement of salary to contract/ contingent employees is on the basis of attendance statments forwarded by the Principal/ Head of the Department concerned. In the case of contingent employees university order has to be issued by the Administrative sections concerned on the basis of the attendence statements and contingent bill has to be forwarded to the Audit section for disbursal of salary, whereas attendance certificates alone are required in the case of Contract employees. Due to the situation of spreading of Covid 19 pandemic in alarming proportions, the government has declared lockdown in the entire Thiruvananthapuram corporation area with effect from 6th July2020 and is being continued till date. Because of this, the centers/departments are unable to forward the hard copies of the attendance statement.

In the previous lockdown period for contract employees the attendance statement was emailed to the Finance Officer. It may also be noted that in the previous lock down period the government had issued orders to consider lock down period as on duty and to disburse the salary accordingly. But now, as the lock down has been declared only on regional basis, the government has not issued any such orders till date. In the above circumstance administrative sanction is required for effecting any relaxations in the usual procedures for the disbursal of the salary of July 2020.

To be more specific, decision has to be taken as to whether their salary for the lock down period may be disbursed and if so, the procedure (with regard to attendance etc;) to be adopted for the same may also be decided. As ordered by the Hon'ble Vice-Chancellor, the matter is placed before the Syndicate for consideration and appropriate decision.

#### **Resolution of the Syndicate**

**RESOLVED** to implement the G.O. (P) No.99/2020/Fin. dated 30.07.2020 and to disburse the salary to contract/contingent employees for the month of July 2020 accordingly.

Item No.15.25. Engaging of Estate Officer- Consideration of- reg.

#### (Ad.AI)

Sri. C Mohanan was engaged as Estate Officer on contract basis at the University Office w.e.f 21.08.2019 for a period of 11 months on monthly remuneration basis as per U.O. No. Ad.A1.3/26675/19 dated 18.12.2019. His period of engagement as Estate Officer has expired on 20.07.2020.

The date of birth of Sri. C Mohanan is 02.04.1960 and he attained the age of 60 in April 2020. As per the resolution of the Syndicate held on 20.06.2019 in item no. 11.38, *person with age upto 65 years can be considered for engagement as non- teaching staff including Sweepers and Cleaners in various University institutions like UITs/UIMs/KUCTEs/UCE*. The post of Estate Officer requires technical expertise with regards to land matters and Sri. C. Mohanan has been continuing as Estate Officer on contract basis since 18.08.2017. Sri. C. Mohanan had held the post of Deputy Collector in Land Revenue Department previously.

As the post of Estate Officer is lying vacant, either Sri. C. Mohanan, Estate Officer on contract basis may be

(i) re-engaged as Estate Officer for a period of eleven months as per the existing remuneration after imposing a mandatory break of one working day for the previous engagement

#### OR

(ii) Steps may be initiated to appoint a new incumbent as Estate Officer on contract basis and Sri. C. Mohanan, former Estate Officer on contract basis may be re engaged till a new incumbent joins duty.

As per orders of the Vice-Chancellor, the matter is placed before the Syndicate for appropriate consideration and recommendation.

#### **Resolution of the Syndicate**

**RESOLVED** not to re-engage Sri. C. Mohanan as Estate Officer.

**FURTHER RESOLVED** to initiate immediate steps to appoint a new incumbent as Estate Officer on contract basis.

**ALSO RESOLVED** to authorize the Vice-Chancellor to nominate an official (Deputy Registrar) to assign the charge of Estate Officer till the new appointment is made.

Item No.15.26. Kerala University Department of Publications-Appointment of the Director in the Department of Publications- Request-Consideration of- reg.

(Ad.DIII)

1. Request dated 01.06.2020, submitted by Sri.Joe Joseph, former

Director, Department of Publications, University of Kerala

2. Note No.KUDP/20-21 dated 09.06.2020 from the Department of Publications

As per reference cited 1st, Sri Joe Joseph, Former Director, Department of Publications has requested to engage him as the Director, Department of Publications, University of Kerala on Contract basis by considering the following;

a) He had been working as the Director, Department of Publications, University of Kerala for about 8 years. He retired from service on 31.05.2020.

b) Although he had approached the Hon.High Court for the extension of his retirement age to 60 years, the Hon.Court disposed the case on 29.05.2020 without accepting his pleading.

As per reference cited 2<sup>nd</sup> the Administrative Officer, Kerala University Department of Publications has informed that since the Director, Kerala University Department of Publications retired from service on 31.05.2020, the smooth functioning of the department has not been possible and there are several matters that requires the attention of the Director such as Printing of text books for various University Courses, forwarding of Contingent Bills, Decision regarding paper for printing of books, issuing of NLC/LC to Sri Joe Joseph, Director(Retired) and to Smt.Lali, Clerical Assistant (Retired) from the Department.

The Vice-Chancellor has ordered to place the request of Sri Joe Joseph, former Director, Department of Publications, University of Kerala, to appoint him as the Director, Department of Publications, on contract basis before the Syndicate for a final decision.

In this regard the following points may be noted.

*i)* As per U.O.No.Ad.DIII.2.53724/2012 dated 04.12.2016 Sri Joe Joseph was appointed as the Director, Department of Publications, University of Kerala w.e.f. 06.11.2012.

*ii)* Sri Joe Joseph had filed a case against the University challenging his retirement from service at the age of 56. The University had taken the stand that the Director, Department of Publications being a non-teaching post had to retire at the age of 56 and not at 60, as in the case of teachers in the University.

iii) The Hon'ble High Court had dismissed his Petition on 29th May 2020 and upheld the stand of the University. In this context appointing Joe Joseph on Contract could weaken the above stand of the University and could find itself in an embarassing situation, if Sri. Joe Joseph files an appeal against the verdict in the Hon'ble High Court.

*iv)* However it may be seen that the post of the Director, Department of Publications is a very crucial and unique one and cannot be kept vacant indefinitely. Urgent steps need to be taken to appoint a Director for the Publication Department.

v) There is no precedence of a procedure of contract appointment to the post of Director, Department of Publications. Charge of Director was handed over to Assistant Director in the previous instance. However at present there are no permanent employees in the post of Assistant Director or Publication Officer.

*vii)* Also in the scenario of the Director, Department of Publications being engaged on Contract basis, the service conditions including remunerations needs to be fixed.

As per the orders of the Vice-Chancellor *the request of Sri Joe Joseph, former Director, Department of Publications, University of Kerala, to engage him as the Director, Department of Publications on Contract basis*, is hereby placed before the Syndicate for consideration and appropriate decision.

#### **Resolution of the Syndicate**

**RESOLVED** that the item be referred to the Standing Committee of the Syndicate on Staff, Equipment and Buildings.

Item No.15.27. Promotion of Section Officers of 2008 batch – Remarks of the Standing Counsel regarding six re-appointed assistants- for consideration-Consideration of reg

(Ad A I)

With regard to the Assistants appointment during 2008, the Hon'ble Court in the common Judgement dated 21.02.2017 in WPC 37082/2007 and connected cases declared that as the selection of the appointed candidates have been already upheld, the University shall grant them all benefits flowing from the respective date/order of appointment including promotions and all consequential benefits in preference to their juniors. The employees of the batch were not given promotion till February 2017due to the pendency of court proceedings. They had been retained in the post of Assistant till February 2017.

The Assistants from 2008 batch were given promotion vide U.O. No. Ad.AI.2/6765/17 dated 23-02-2017 by complying with the Judgement dated 21.02.2017 in WP(C) 491/2012. Many complaints were received against the U.O. No. Ad.AI.2/6765/17 dated 23-02-2017. The Vice Chancellor ordered to constitute an Anomaly Rectification Committee (ARC) to look into the

allegations raised against the U.O dated 23-02-2017. The main allegation against the U.O dated 23-02-2017 was the seniority accrued in the cadre of Assistant (Senior Grade) was not considered for promotion to the cadre Assistant (Selection Grade) and for the further promotion to the post of Section Officer. The ARC submitted its report dated 10.08.2017. A group of employees approached the Hon'ble Court seeking implementation of the report dated 10.08.2017 submitted by the ARC by filing WP (C) 30240/2017. The Hon'ble Court disposed this Writ Petition on 13.10.2017 with the direction to the University to call for and obtain objections, if any, as against the report, within a period of 'two weeks' from the date of receipt of a copy of the judgment and to take a final decision within a further period of one month and to effect promotions without any further delay."

Accordingly objections were further called for and the ARC submitted its final report on 4.11.17. Considering the recommendation of the ARC, the Vice-Chancellor directed to seek legal opinion from the Legal Adviser. The Legal Adviser recommended to provide equal opportunity to all and also opined that it will be proper to effect promotions by reckoning the date of occurrence of vacancy as on 03.07.2010, since the last incumbent of 2008 batch assistants joined service on 03.07.2008. The Vice-Chancellor approved the same and University Order dated 03.01.2018 was issued.

Again numerous complaints were received against the U.O dated 03.01.2018 alleging irregularities. The petitioners of WPC 30240/2017 again filed another Writ Petition (WP(C) 1366/2018) before the Hon'ble Court and the Hon'ble Court on 08.02.2018 issued an interim order staying further promotions from the U.O dated 03.01.2018. Subsequently another group of employees also filed WP(C) 5731/2018 challenging the U.O dated 03.01.2018. In view of the complaints received against the U.O dated 03.01.2018, it was decided to form another ARC, comprising officials, to look into the alleged anomalies.

The Hon'be Vice - Chancellor has ordered to constitute a New Anomaly Rectification Committee (ARC) to verify the complaints received against the order in U.O. No Ad.AI.2/6765/18 dtd 03/01/2018 and the same was constituted vide U.O.No.Ad.AI.4.6765/2018 dated 05.03.2018. The Committee was entrusted to verify the service books of all the Assistants appointed during 2008 to ascertain the actual date of passing of Account Test and Secretariat Manual Test and also state their eligible date of promotion to various categories based on the relevant rules. The Committee verified the service books of all the assistants appointed during 2008 and submitted a report on 13.03.2018. A Circular was issued on 13.03.2018 intimating the publication of the list prepared by the new ARC to the employees concerned. Altogether 35 complaints had been received.

Subsequently two Writ Petitions (WPC 8866/2018 & WPC 9290/2018) were filed against the formation of the new ARC which was intended to examine the alleged anomalies crept in the U.O. dated 03.01.2018 and to stay the proceedings in pursuant to the circular dated 13.03.2018. It was submitted by the University before the Hon'ble Court that the matter will be considered by the Syndicate of the University and shall report it to the Hon'ble Court before taking a final decision. The Hon'ble Court vide interim order dated 27-03-2018, made clear that the proceedings in pursuant to circular dated 13.03.2018 shall go on, however finalisation of such proceedings shall be made only after obtaining further orders from the Court. Complying the orders of the Hon'ble Court, the Vice-Chancellor has accorded sanction to resume the process of considering the complaints in pursuant to the circular dated 13.03.2018. Accordingly the report prepared and submitted by the ARC on 24.04.2018 was considered by the Syndicate held on 10.05.2018 and it was resolved to accept the report and to inform the Standing Counsel to obtain necessary orders from the Hon'ble Court of Kerala for its implementation.

University filed an IA before the Hon'ble High Court of Kerala on 24.07.2018 to permit the University to implement Syndicate resolution (Item No. 35.72. Additional Item No.03) held on 10.05.2018 and to fill 29 vacant posts of Section Officer. UO has been issued to promote 24 incumbents from the list approved by Syndicate without affecting Smt. Beena S.G. and Sri. Renjith Sekhar R as directed by the Court. Accordingly U.Os. dated 16.08.2018 were issued.

Sri. Sreenath.S & Others filed Contempt Case (Civil) COC No. 1755/18 against the issuance of the promotion orders dated 16.08.2018. The Legal Monitoring Committee held on 14.11.2018 recommended the following:

a) decision on the fixation of pay to the promoted posts of incumbents in 2008 batch Assistants and payment of arrears may not be considered now, since there is an Interim Order dated 27.07.2017 in WA 706 & 788/2017 As of now, Interlocutory Applications need not be filed by the University to vacate the Interim Order dated 27.07.2017.

b) until CCC No.1755/2018 filed by Sreenath.S and others is closed by the Hon'ble High Court, it is not advisable for the University to file IA for filling the vacant post of Section Officers by promotion. c) if the situation so warrants the Vice-Chancellor be authorized to withdraw the U.O. Nos. Ad.AI.2/6765/2018-1,2&3 dated 16.08.2018 and to issue a fresh University Order accordingly promoting the same 24 incumbents who were promoted as Section Officers vide U.O. No.Ad.AI.2/6765/2018-3 dated 16.08.2018.

The Syndicate in its meeting dated 16.11.2018 has resolved to agree to the above recommendations of the Legal Monitoring Committee. The standing Counsel vide letter No. TA/SC-LO-13/2019 dated 13.02.2019 informed that the contempt case has been closed recording the decision of the Syndicate to withdraw Annexures IX, X and XI orders. The said decision submitted before the Hon'ble Court as per the statement dated 16.01.2019 has been extracted in paragraph 4 of the judgment. Therefore the orders have to be withdrawn forthwith and those orders in force prior to the interim order dated 27.03.2018 would revive instead. Fresh orders regarding the promotion to the post of Section Officers to the 24 vacancies for which permission was granted as per interim order dated 14.08.2018 and to the 12 vacancies granted as per the interim order dated 29.01.2019 have to be issued specifically mentioning that the same are being issued provisionally subject to the final outcome of W.P.(c) Nos.1366, 5761, 8866 and 9290 of 2018. Hence, the U.Os dated 16.08.2018 have been modified and fresh U.O was issued accordingly. Further promotions to the post of Section Officer were being made with the permission of the Hon'ble High Court from the list approved by the Syndicate on 10.05.2018.

It may be noted that the employees of 2008 batch are eligible for promotion to the post of Section Officer (Hr.Gr) wef 01.06.2019. In this context, as per the orders of the Hon'ble Vice-Chancellor Standing Counsel was requested to take earnest steps to get the High Court stay vacated for the disbursement of monetary benefits to the 2008 batch of Assistants and to obtain a favorable decision from the court in the cases related to seniority dispute urgently by implementing the resolution of the Syndicate held on 10.05.2018.

The Standing Counsel furnished the following;

"The above referred cases came up for consideration before the Hon'ble High Court of Kerala yesterday (1.7.2020). The said posting was granted by the Hon'ble Court on the basis of the submissions made on behalf of the University on the date of last posting. But the cases were adjourned again. I insisted on the hearing to be commenced on 1.7.2020 itself so that the matter could be listed again as a part heard matter on a later date, if some among the counsel had any personal inconvenience yesterday. This request was opposed by 2 counsel and therefore the case was adjourned to 16.7.2020.

In the last about 2 years this batch of cases is facing the same fate as a result of which the stalemate in the University in granting eligible promotions is continuing. The University as a respondent in all these cases has an inherent legal disability to initiate any final hearing as the cases have been filed by the petitioner employees and not by the University. But the fact that the present impasse in promotions is really creating a vacuum in our middle level administrative machinery has to be reckoned with the seriousness the same deserves. Therefore to overcome this crisis it is essential that the University should take initiative in moving the Hon'ble Court for modification of the earlier interim order interdicting the University from passing any further orders and permit the University to provisionally grant promotions on the basis of the seniority list approved by the Syndicate in its meeting dated 10.5.2018. This in fact is not going to create any prejudice to the rival claims as the direction sought to be issued is only for provisional promotions subject to the final outcome of the batch of cases. Since this is a policy matter I request that appropriate decision may be taken and informed for enabling me to file a suitable application. Please treat this as most urgent as any interlocutory application in this regard has to be filed if possible this week itself''.

It may also be noted that 6 employees of 2008 batch were reappointed (in July 2018) after the submission of Report of new ARC (ie, after 10.05.2018). Hence they were not included in the said list. Hence permission may also be obtained from the Hon'ble Court to include them in the said list in their eligible positions. As per the orders of the Vice-Chancellor remarks furnished by the Standing Counsel was placed before the Standing Committee of the Syndicate on staff, equipments and buildings for consideration.

The Vice Chancellor, while considering the minutes of the Standing Committee of the Syndicate on staff, equipments and buildings on 03.07.2020 (copy appended), approved the minutes and has ordered "Due to exigency for additional item no.3, an IA be filed in the Hon'ble High Court (subject to reporting to Syndicate)". It has also been ordered to send a letter to the Standing Counsel in this regard. Accordingly, a note dated 13.07.2020 was given to the Standing Counsel.

The Standing counsel, vide Letter No. SC/Lt.No.24/2020 dated 14.07.2020, forwarding the draft of the affidavit and petition seeking permission of the Hon'ble High Court of Kerala for the provisional promotion to the 44 vacancies of Section Officer (Higher Grade), opined that " the matter of 6 employees mentioned in the note cannot be included in the affidavit as such inclusion is liable to be considered as an abuse of the process of the Court. The subject matter of all the cases is the seniority issue based on the ARC Report and all developments consequent to the same culminating in the decision of the Syndicate held on 10.5.2018. If the 6 employees are also included in the said seniority list that would definitely alter the validly approved seniority list now in force which is the subject matter of the pending cases. It has also been opined that there is no such decision taken by any competent authority of the University modifying/altering the decision of the Syndicate dated 10.5.2018 for the inclusion of the 6 employees in question. The Standing Counsel is also of the view that it is only proper and legal to present the draft of the affidavit and the IA for the approval of the Vice- Chancellor as the decision in this regard can be only by invoking the powers under Section 10(13) of the Kerala University Act 1974".

IA has been filed for promoting 2008 batch Section Officers as Section Officers (Hr.Gr.). As instructed by the Standing Counsel the case of 6 re-appointed Section Officers has not been included as they are not in the list approved by the Syndicate on 10.05.2018.

As per per the orders of the Vice-Chancellor remarks furnished by the Standing Counsel is placed before the Syndicate for appropriate consideration and recommendation.

#### Resolution of the Syndicate

**RESOLVED** that the item be referred to the Standing Committee of the Syndicate on Staff, Equipment and Buildings.

BSNL has intimated that the NMEICT connectivity was provided to the University in the year 2010 is due for renewal w.e.f. 29.09.2020. A meeting was held at PVC chamber on 29.06.2020 with BSNL team. At this meeting, BSNL submitted a proposal for renewal of 1Gbps NMEICT connectivity for 10 years in advance or for one year in advance. The renewal charges are as detailed below.

The Director, Computer Centre has remarked that the BSNL 1Gbps NMEICT connectivity was provisioned to the University of Kerala, Trivandrum in the Year 2010 for 10 years. BSNL informed through their letter that NMEICT connectivity is due for renewl w.e.f. 29.09.2020. NKN connectivity under NMEICT project interconnects all knowledge and research institutions in the

country and enables collaborative research, development and innovation amongst NKN connected institutes. NKN connectivity acts as backbone of the University of Kerala. At present NKN connectivity is used for internet connectivity at both Palayam and Kariyavattom campus of the University of Kerala. Generally, Internet connectivity available through this connection is sufficient for the essential services of University like on-line meetings, seminars etc. Public Ips granted to the University through the NKN connectivity is used to host different University website like research portal, library portals, DDFS, on-line question paper etc. It is also helpful for conducting video conferencing systems with various Universities coming under NKN connectivity.

As per the orders of the Hon'ble Vice – Chancellor, the matter is placed before the Syndicate for Consideration.

#### **Resolution of the Syndicate**

**RESOLVED** to approve the proposal submitted by BSNL for the renewal of 1Gbps NMEICT Connectivity for ten years.

**FURTHER RESOLVED** to authorize the Vice-Chancellor to have a negotiation with BSNL and reduce the yearly payment to Rs.18 lakh per annum.

Item No.15.31. Unitary degree course in Law - Inter Collegiate Transfer – Request from Sri. Arjun Babu T P – Consideration of- reg.

#### (Ac.AIII)

Sri. Arjun Babu T P, who was admitted during 2017-18 to Unitary Degree course in Law at Govt. Law College, Thiruvananthapuram, has requested for inter college transfer to the V Semester to CSI Institute of Legal Studies, Cheruvarakonam (Self Financing) during 2020-21 by relaxing the norms for inter college transfer. It is stated that he has completed IV semester and now wishes to be transferred from the college since he fears he cannot complete the course due to the threats prevailing in the parent college. His studies were discontinued after completing the IV semester as he was suspended from the college due to some issues .The candidate will have to take readmission in the V semester during 2020-21 to pursue his studies as he has lost one academic year. The candidate has also expressed his willingness to join the 4th semester in another college after the cancellation of registration to the 4th semester.

A complaint on this matter was filed on 23.11.2019 before Students' Grievance Cell, the Pro-Vice Chancellor and the Vice Chancellor. The Principal, Govt. College, Thiruvananthapuram has expressed consent in the matter of Arjun Babu T P seeking admission in the V semester at CSI Institute of Legal Studies, Cheruvarakonam. Likewise, the Principal, CSI Institute of Legal studies college has informed that they have no objection in admitting the candidate to V sem in their college. The tabulation section has reported that the candidate had registered upto IV semester (Sept. 2019) of unitary LLB degree examinations.

As per the prescribed norms for inter college transfer for LLB degree course, 'transfer shall be permitted in the Second to Fourth Semester in the Three year LLB stream and within the first month of the commencement of the semester to which admission by transfer is sought'. It is to be noted that, the classes for IV semester during the academic year 2020-21 commence only in February, 2021.

As per the orders of the Vice-Chancellor the matter was placed before the Standing Committee of the Syndicate on Affiliation of Colleges at its meeting held on 11/06/2020 and the committee recommended to conduct the hearing of the candidate on 15<sup>th</sup> June, 2020 at 11.00 am. After hearing the candidate, the Committee recommended to consider the matter in favour of the candidate, who was suspended from the college after completing IV semester, and grant him inter college transfer along with readmission to the V semester of Unitary degree course in Law from Govt. Law College, Thiruvananthapuram to CSI, Institute of Legal Studies, Cheruvarakonam, during 2020-21 considering the volatile nature of the issue, subject to Legal opinion. The Legal Advisor quoting the conditions in clause 3 of Chapter III of the Kerala University First Ordinances, 1978, has opined

that there is no legal impediment in granting inter college transfer to the candidate as he has produced the necessary documents and particularly as he apprehends threat to his life.

In this context, it is pertinent to note that on issues relating to the violent incidents in University college, Thiruvananthapuram and Govt. Law college, Tvm, there are cases filed before the Hon'ble High Court of Kerala seeking intervention by the University to ensure that the academic career of the students under suspension do not suffer in the context of the severe Law and order issues prevailing in the said colleges.

Hence, as per orders of the Vice-Chancellor the recommendation of the Standing Committee of the Syndicate an Affiliation of Colleges along with the legal opinion of the Legal Advisor to grant inter college transfer along with readmission to the V semester Unitary degree course in Law from Govt. Law College, Thiruvananthapuram to CSI, Institute of Legal Studies, Cheruvarakonam, during 2020-21 to Sri. Arjun Babu T P is placed before the Syndicate for consideration and approval.

#### **Resolution of the Syndicate**

**The Syndicate** considered the opinion of the Legal Adviser and **RESOLVED** to grant intercollege transfer from Govt. Law College, Thiruvananthapuram to CSI, Institute of Legal Studies, Cheruvarakonam, during 2020-21 to Sri. Arjun Babu T.P along with readmission to the V semester Unitary degree course in Law.

As per the prospectus for UG admission 2020, clause 4.4, "after completion of the registration process, the candidates shall submit a proforma in prescribed format to the colleges of their choice among the colleges they have opted while registering online." As per UG Prospectus 2020, the University will not be conducting online centralized allotment for BPA Programmes and those candidates who wish to apply for the same need to apply directly to the Colleges concerned.

E-mail has been received from the Principal, SST Govt. College of Music regarding submission of applications to BPA programmes to the college.

It has been stated that since the courses are related to vocal and instrumental music, it is compulsory to conduct aptitude test for the candidates. Hence the applications were issued and scrutinized manually and eligible candidates were called for aptitude tests. # Item No.15.38 Releasing Retirement benefits to Dr.Padma Rao.G without getting thumb impression-Consideration of-reg.

#### (DR (Audit))

Dr.Padma Rao.G, Professor, Department of Malayalam, retired from service on 30.04. 2019 has requested to calculate his pensionary benefits only after getting his prior service reckoned.The order reckoning his prior service was issued on 14.05.2020 and subsequently the pensionary benefits were sanctioned vide U.O.No.Ad.AIII.a/SP/22983/2020 dt.12.06.2020.

The release of retirement benefits are pending as the pensioner has not reported for getting thumb impression and signature on the Pension Payment Order.

Dr.Sheela Kumari, w/o Dr.Padma Rao.G vide request dated 23.07.2020 has intimated that the pensioner met with an accident on 09.06.2020 and still under medical treatment. She has produced Treatment Summary from KIMS Hospital, Thiruvananthapuram and has requested to release the retirement benefits of her husband for meeting the expenses for medical treatment.

Considering the present condition of social spreading COVID-19 pandemic and the medical condition of the pensioner it is not advisable to direct the section to visit the hospital and complete the formalities for releasing the payments.

The Legal Advisor had opined that taking in to consideration the current Global Health Crisis/ Pandemic and also the fact that the retiree had met with an accident incapacitating him from personally appearing before the competent officer to give thumb impression, it is only reasonable and just to take an empathetic and humanitarian approach towards the plight of the retiree. It is opined that, the exemption from giving his thump impression be afforded to the pensioner in light of the circumstances and in doing so will not result in any irregularity or misappropriation as the amount due to the retired employee will be directly credited to his bank account. Moreover, the lack of thumb impression is a curable defect that can be rectified once these circumstances are favorable.

The matter of releasing the retirement benefits in respect of Dr.Padma Rao.G without getting thumb impression and on the strength of the Treatment Summery from KIMS Hospital, Trivandrum and completing the pending formalities at earliest possible date is placed before the Syndicate for consideration and appropriate decision.

#### Resolution of the Syndicate

The Syndicate considered the opinion of the Legal Advisor and **RESOLVED** to release the retirement benefits in respect of Dr.Padma Rao.G, Professor, Department of Malayalam (Rtd.) without getting thumb impression and on the strength of the Treatment summary from KIMS Hospital, Trivandrum and completing the pending formalities with immediate effect.

Item No. 15.39 Replacing of acacia trees with indigenous trees at Kariavattom-Consideration of-reg.

#### (Ad.B1)

An MoU has been executed between the University and the Social Forestry Division for implementing the project of replacing acacia trees with indigenous trees at 20 hectares of land at Kariavattom Campus.

In the mean time, the Joint Registrar, Administration has informed that the related works as per the MoU executed with Social Forestry Division, is in progress. However, an action plan has to be conceived for the clearing of all acacia trees, with in an exact time frame. The numbering and value assessing of trees, move at a snail's gallop. As discussed with the authorities of Social Forestry Division, the value of trees/ logs dumped in the campus will be assessed by the SFD, within the project period, if required officially. The clearing of land and planting of tree saplings has to be completed prior to monsoon. Urgent intervention is required on the matter, as the project may cease when the monsoon begins. Also, the speeding up of the aforesaid work may be helpful to boost up the funding of various projects in the campus and also to make the campus, acacia free, before the NAAC visit. As per the orders of the Vice Chancellor, the matter of *entrusting the Social Forestry Division to assess the value of acacia trees/ logs dumped in the campus within the project period and speeding up of the project*, is placed before the Syndicate for consideration.

submitted by the University Engineer the work was completed on 05.09.2018), no action was taken to refund the fine amount of Rs.70,080/- (Rupees Seventy Thousand and Eighty only).

Since the request of the contractor dated 19.03.2019 was not received in the planning section, a clarification was sought from the University Engineer and the University Engineer vide letter No.DB2/Drainage/RUSA/2018 dated 28.05.2020 has clarified that "the fine amount recovered from the contractor Sri.Thomas Jacob for the delay in completion was imposed as per the norms.The Assistant Executive Engineer and the Assistant Engineer concerned in the proforma for extension of time of completion have recommended to extend the time with suitable fine.More over the contractor Sri .Thomas jacob had executed a supplementary agreement for deducting the fine amount, hence the fine for delay was calculated and an amount of Rs.70,080/- (Rupees Seventy Thousand and Eighty only) was deducted from the bill amount.

In response to the email dated 15.06.2020 Director (P&D), the University Engineer has forwarded the request of the contractor Sri.Thomas Jacob dated 19.03.2019 vide email dated 17.06.2020. The contractor has intimated that repair works of drainage system and allied works in the Science Block-I (Geology Block Building) at Kariavattom Campus was completed on 05.03.2018 and submitted the bill.But the bill amount was not released to contractor evenafter one year of completion of the work and the Assistant Executive Engineer has intimated the contractor that they had delayed the work for 114 days.The contractor has further intimated that they had to wait for holidays to complete the work since most of the work could not be done during the class time of the Department. Further he has stated eventhough explanation for the delay of the work had been intimated to the concerned, he was purposefully imposed the fine amount because he had complained aganist the Assistant Executive Engineer. The contractor also emphasised that he had to struggle for the completion of the work and requested to refund the fine amount imposed on him.

As per the orders of Vice Chancellor the matter of refund of fine amount of Rs.70,080/-(Rupees Seventy Thousand and Eighty only) to the contractor Sri.Thomas Jacob in connection with the repair works of drainage system and allied works in the Science Block-I (Geology Block Building) at Kariavattom Campus, is placed before the Standing Committee of the Syndicate on Planning & Development for consideration and appropriate recommendation'.
