As per Statute 9 under Chapter 6 of the Kerala University First Statutes, 1977, the Syndicate shall, before the first day of January every year, examine the financial estimates of income and expenditure which has been prepared by the Finance Committee for the ensuing financial year and forward the same to the Senate. As such, the draft financial estimates for the year 2019-20 has been considered by the Statutory Finance Committee at its meeting held on 14.12.2018 and recommended to place the same before the Syndicate for consideration.

Item No.01.07 Printing of Kerala University Diary 2019–Consideration of –reg. (Ad.Misc)

As per Item No.04.54.05 of the minutes of the meeting of the Syndicate held on 31.08.2018; it was resolved to print 6000 copies of University Diary 2019, with the same specifications of University Diary 2018 and to print 1000 mini (pocket) diaries in six volumes for the whole year, each volume containing a calendar period of two months.

The Finance, vide endorsement FOS/ 2650/ Finance I/ dated 04.10.2018, has agreed to a provisional payment of Rs.6,00, 000/- (Rupees Six lakhs only) towards the expenses for printing the Diary.

As per the Syndicate decision, University has issued the Order No. Ad.Misc./2/ Diary 2019/2018 dated 11.10.2018 to implement the following direction of Syndicate.

- 1) To print and publish 6000 copies of the University Diary 2019, with the following specifications:
 - (i) Size- $\frac{1}{4}$ Crown
 - (ii) Paper-18.6. Kg/70 GSM Maplitho
 - (iii) CT Plate Printing (CT plate printing and case binding works being entrusted with outside press)
 - (iv) The cost of Diary being fixed as Rs.150/- per copy

2) To Print 1000 mini (pocket) diaries in six volumes for the whole year, each volume containing a calendar period of two months.

- 3) A provisional payment of Rs.6,00,000/- (Rupees Six lakhs only) being paid to Sri.S. Rajasekharan, General Foreman in-charge of the Superintendent, University Press, towards the expenditure to be incurred in connection with the printing of University Diary 2019.
- 4) 75 copies of the Diary being made available to the Syndicate Members, free of cost and a maximum of 75 copies, at half price, on request.
- 5) The Diary shall be sold to pensioners/contract employees at half price i.e. Rs.75/per copy.
- 6) One Diary each to the Syndicate Members and Statutory Officers, being imprinted with their names on it.

But the University received a circular No. 108/2018/Finance dated 22.11.2018 from the Finance department, Govt. Of Kerala that banned the Grant – in Aid institutions/ Boards/ Corporations from printing Diary this year as part of financial restrictions imposed by the Government.

On the basis of this Circular the Vice Chancellor Convened a meeting of Statutory Officers on 15.12.2018 at 2.00 pm. to discuss matters related to the printing of University Diary, 2019.

Since the Diary is extensively used by the employees, faculties, college authorities, etc as an inevitable handbook for academic & day to day official activities, the Committee recommended to seek the consent/concurrence of the Govt. (Finance Dept.) (to avoid audit objection) for printing & publishing the University Diary 2019 and also recommended to take the following measures for reducing the printing charges of the Diary.

1. Not to Print Mini (pocket) Diary

2. To print only 5,500 copies of the Diary

3. To delete the details regarding Rate of fees, Exam centres and University merit scholarships from the information portion of the Diary and to make these details available in the University Website.

4. To include three days in each page of the calendar portion of the Diary.

5. To avoid hard binding of the Diary.

Now the Ad.Misc. section has received the 7th proof of the diary 2019 from the Director, Dept. of Publications for approval.

As per orders of the Vice-Chancellor, the matter of printing University Diary 2019 is placed before the Syndicate for Consideration.

RESOLVED to accept the spirit behind the Government directive seeking grant-in-aid institutions to desist from printing diary for the year 2019 in view of financial restrictions. The Syndicate resolved to stop the printing and distribution of University diary.
