**Introduction**

The Department of Law is established in 1988, is actively engaged in post graduate teaching and research. Every year 100% pass in the examination with either distinction or first class is achieved.40% of the students are qualifying the National Eligibility Test of UGC to selection of teachers.50% of law teachers in Kerala recruited after 2005 are from the Department. Department is actively engaged in extension activities like giving legal aid to poor through permanently established Kerala University Legal Service Clinic, Legal Literacy Camps, Training Programmes,Seminars,Workshops.

**Programme Structure and Duration**

The Post Graduate Diploma in Human Rights (PGDHR) is a **full time two semester programme**. The Course is open to any stream Graduate Degree holders. However preference is be given to those who have undergone a Graduate Course or Foundation Course in Human Rights. The Course shall be One Year Duration (2 semesters) with a total of 9 papers. In addition candidate shall be required to complete the project work.

**Admission Procedure:** Interested candidates are required to submit the application form (can be downloaded from web site <https://www.keralauniversity.ac.in/>) duly filled in, with the required documents (as mentioned in the instructions) along with the required application fee. The application fee of **Rs. 100/-** may be paid in cash at the University Cash Counter. The fee can also be paid as crossed DD for **Rs. 110/-** issued by any branch of nationalised banks, drawn in favour of “**The Finance Officer, University of Kerala**”, payable at Thiruvananthapuram. The purpose of remittance and the name of person for whom the remittance is made should be clearly stated on the backside of the DD. The application fee is non-refundable / non-transferable.

The application forms complete in all respects along with attested copies of mark lists of all examinations (semesters/years) should be submitted to “*The Head of the Department, Department of Law, University of Kerala, Kariavattom campus, Thiruvananthapuram – 695 581*” on or before **22<sup>nd</sup> January 2025**. **Application form received without the application fee, shall be rejected.**
