ORDER

The University of Kerala vide reference cited (1)issued notification inviting applications for affiliation of new colleges/ courses/increase in intake/additional batches in affiliated colleges during 2021-22 as per the resolution of the Syndicate vide reference (2) cited above.

The Syndicate vide paper read as (3), considered the applications received within the statutory prescribed time limit and resolved to conduct local enquiry in colleges on the basis of the applications that satisfied all the mandatory requirements

prescribed by the University.

Local enquiry as stipulated in Statute 8 of Chapter 24 of the Kerala University First Statutes, 1977 was conducted in the respective colleges and the Syndicate vide reference cited (5) considered and resolved to approve all the inspection reports for new courses except in the cases of Carmel College, Muhamma and Sree Narayana Guru College of Advanced Studies, Cherthala. The Syndicate resolved to recommend B.Sc. Mathematics in Carmel College, Muhamma, and BCA course in Sree Narayana Guru College of Advanced Studies, Cherthala as against the recommendation in the inspection reports submitted.

The recommendations approved by the Syndicate were forwarded to the Government vide letter cited (6), seeking its views on the recommendations.

Contrary to the recommendation of the Syndicate to seek remarks on granting NSS College of Arts and Science, Perayam, the affiliation to B.Sc Chemistry in Manager vide letter cited (7) requested to consider granting affiliation to B.A History programme in the college. The Vice Chancellor, considering the request, ordered a local enquiry in the institution. The inspection report submitted by the nominated team was considered by the Standing Committee of the Syndicate on Affiliation of Colleges vide reference cited (8) and B.A.History was recommended at the same time calling off the earlier recommendation of B.Sc Chemistry. The said recommendation approved by the Vice Chancellor in exercise of the powers conferred under 10(13) of the Kerala University Act, 1974, was reported to the Syndicate vide reference (9) above. The change in the recommended course in NSS College of Arts and Science, Perayam, was intimated to the Government and its views were sought vide reference cited (10).

The Government vide order read (11) accorded administrative sanction to start new self-financing courses in Self-financing colleges affiliated to University of Kerala during the academic year 2021-'22. The Standing Committee of the Syndicate on Affiliation of Colleges vide paper read as (12) above considered the Government order and recommended to conduct inspection in colleges wherever Government rendered positive views and to approve the list of members of teams with subject experts and members, Syndicate to conduct inspection in colleges, submitted by the Convenor, Standing Committee of the Syndicate on Affiliation of Colleges. The recommendation was approved by the Vice-Chancellor and the same was reported to the Syndicate vide reference (13) above.

The Standing Committee of the Syndicate on Affiliation of Colleges vide paper read as (14) considered the reports of the final inspection conducted in the colleges for affiliation of new courses and the committee recommended to grant conditional affiliation, as per Statute 12 Chapter 24 of the Kerala University First Statutes 1977, to the following new courses in the existing affiliated colleges, on self financing basis during the academic year 2021-'22 subject to fulfillment of procedural formalities of affiliation.

recommended to conduct another detailed inspection in the colleges within 3 months to ascertain the academic facilities arranged by the colleges in respect of new courses. The recommendation was approved by the Vice-Chancellor in exercise of the powers conferred under 10(13) of the Kerala University Act, 1974, and the same was reported to the Syndicate vide reference (15) above.

The Educational Agencies of all the above colleges mentioned have fulfilled the procedural formalities as prescribed by the University.

Sanction is therefore, accorded by the Vice Chancellor, for the Conditional Affiliation, as per Statute 12 in Chapter 24 of the Kerala University First Statutes, 1977, to the above mentioned new courses in existing Affiliated Colleges during the academic year 2021-'22.

The Affiliation granted is provisional and subject to the following conditions:

- 1. The admissions shall be made in accordance with the statutory regulations of the University and the State Government from time to time.
- 2. The management of the Institution shall not close the Institution or the Institution shall not discontinue instruction in any course(s) or start any new course(s) or alter intake capacity of seats without the prior approval of the University.
- 3. No excess admission shall be made by the Institution over and above the approved intake under any circumstances.
- 4. The Institution shall not conduct any course(s) in the same premises / campus and / or in the name of the Institution without prior permission / approval of University.
- 5. No capitation fee shall be charged from the students / guardians of students in any form.
- 6. There shall not be any additional financial commitment on the part of the Government and the University.
- 7. The Un-aided Colleges shall have to pay the fee for Infrastructure Development and Maintenance of the University before 31st March every year, in advance, as prescribed in the Ordinance, to provide service to these Course(s) as they are affiliated on condition that there will not be any additional financial commitment on the part of the Government / University.
- 8. All infrastructural and instructional facilities for higher semesters shall be made available in time to ensure the quality of education provided.
- 9. The period of affiliation shall be one year/ till further orders by the University.
- 10. Further, the Institution shall strictly follow all the provisions contained in the Kerala University Act, 1974, the statutes framed there under, and the regulations prescribed by the Central Regulatory Bodies viz., UGC, NCTE, AICTE, BCI etc. Any violation of the above shall call for liability upon the Educational Agency.
- 11. Continuance of affiliation to the new courses shall be granted only after conduct of Re-inspection to verify compliance to the requirements noted by the University.

Orders are issued accordingly.
