Amendment to Clause (iii) of Statute 5 B - Financial Powers of the Vice-Chancellor, amendment by way of Introduction of new Statute 11 A - 'Financial Powers of the Pro Vice-Chancellor' and amendment to Clause (xii) of Statute 17(2) - "Other powers of the Registrar" under Chapter 2 - 'Officers of the University' of the Kerala University First Statutes, 1977 - enhancement of Financial Powers of Vice-Chancellor, Pro Vice-Chancellor

The following amendments to the Kerala University First Statutes, 1977 were passed by the Senate at its meeting held on 23/07/2022 vide item no. (II) 13

Clause (iii) under Statute 5 B-"Financial Powers of the Vice -Chancellor" in Chapter 2- "Officers of the University" of the Kerala University First Statutes, 1977

"To accord sanction for expenditure including works up to a maximum of **Rs.10,00,000 (Ten Lakh only)** where the following conditions are satisfied:

- (a) The work is one included in a scheme approved by the Syndicate;
- (b) Funds have been provided in the University Budget,"

Introduction of new Statute 11(A)-"Financial Powers of the Pro Vice-Chancellor", after Statute 11, in Chapter 2 -"Officers of the University" of the Kerala University First Statutes, 1977

11(A), Financial Powers of the Pro-Vice Chancellor "to accord sanction for all works original or repairs up to a maximum of **Rs.5,00,000/- (Five Lakh Only)** where the following conditions are satisfied:-

- (a) The work is one included in a scheme approved by the Syndicate;
- (b) Funds have been provided in the University Budget"

Clause (xii) of Statute 17 (2) -"Other powers of the Registrar "Under Chapter 2 -'Officers of the University' of the Kerala University First Statutes, 1977"

"To sanction expenditure on all contingencies for amounts not exceeding **Rs.2,00,000/-(Two Lakh only)** on each case provided that,

- (a)the purchase has been previously approved administratively by a competent authority; and
- (b) the expenditure proposed for sanctioning is derived from quotations approved by the Stores Purchase Committee and the Vice Chancellor".

The Hon'ble Chancellor, in exercise of the powers conferred under Section 35(5) of the Kerala University Act, 1974 was pleased to give his assent to the above amendments on 09.04.2024 and the above amendments to the Kerala University First Statutes, 1977 shall come into force with effect from that date.
