The Standing Committee of the Syndicate on Examinations considered the representation of the candidate and recommended to refer the matter to the Standing Committee of the Syndicate on Finance. The Syndicate, vide paper read as (2) above, resolved to approve the same.

The Standing Committee of the Syndicate on Finance at its meeting held on 30.4.2024 considered the matter as a special case and recommended to reduce the fee for effecting name correction in the mark lists and Degree Certificates for transgender candidates owing to gender change, to 50% of the existing rate. The Syndicate resolved to approve the same vide paper read as (3) above.

Sanction has been accorded by the Vice Chancellor to reduce the fee for effecting name correction in the marklists and Degree Certificates of transgender candidates, owing to gender change, to 50% of the existing rate.
