ORDER

The enquiry fee of Rs.2,000/- (Rupees Two Thousand only) is levied from the candidates caught for suspected cases of malpractice in University examinations and additional fine of Rs.1000/- (Rupees One Thousand only) from candidates who fail to appear for the hearing on the stipulated date fixed by the University as per UO read as (1) above.

The Syndicate held on 11.11.2024 vide paper read as (2) above resolved to approve the recommendations of the Standing Committee of the Syndicate on Finance to enhance the Malpractice Enquiry Fee to Rs.3,000/- (Rupees Three Thousand only) and further to refund the fee to the exonerated students as per the existing guidelines.

The Syndicate held on 23.12.2024, confirmed and approved the preliminary minutes of the meeting of the Syndicate held on 05.11.2024 and 11.11.2024, with the following modification to the resolution under Item No. 15.93.15 vide paper read as (3) above. It was resolved that the resolution be added to Item No. 15.93.15 "further resolved that, for the candidates who fail to attend the first hearing, the fine of Rs.1,050/- (Rupees One Thousand and Fifty only) presently imposed on such candidates in addition to the Malpractice Enquiry Fee, be retained as such".

Sanction has therefore been accorded by the Vice-Chancellor for the following:

- 1) to enhance the Malpractice Enquiry Fee to Rs.3,000/- (Rupees Three Thousand only) and to refund the fee to the exonerated students as per the existing guidelines.
- 2) to retain the fine of Rs.1,050/- (Rupees One Thousand and Fifty only) in addition to the Malpractice Enquiry Fee, imposed on candidates who fail to attend the first hearing as such.

Finance has given concurrence to the revision vide paper read as (4) above.

Orders are issued accordingly.
