ORDER

The meeting of the Syndicate vide paper read as (1) above considered the request for conducting special examination for the students who had attended the preparatory camp of NCC and resolved that special examination will be conducted to only those candidates who had attended camps using University Budget provision. Further, the meeting of the Syndicate vide paper read as (2) above resolved that the word 'camps' in the resolution of the Syndicate held on 22.11.2019 vide Item No. 06.62.32 be corrected as 'events (Sports/Arts)'. Also resolved that special examination will also be conducted to those candidates who had attended such events of State/National/International levels.

Also, the meeting of the Syndicate vide paper read as (3) above while considering the request of a candidate to appear for the special examinations who had attended Pre Republic Day and Republic Day Camps and resolved that the NCC candidates who participate in the Republic Day Camp at Delhi may also be considered along with the eligible candidates under Sports/Arts segments for the conduct of special examination.

Sanction has therefore been accorded by the Hon'ble Vice Chancellor to conduct special examination to those candidates who attended events (Sports/Arts) using University Budget provision and to those candidates who attended such events of State/National/International levels and also to the NCC candidates who participated in the Republic Day Camp at Delhi
