The Syndicate, vide paper read as (5) above, considered the requests and resolved to permit the closure of the M.Sc Electronics programme and the suspension of the M.Sc Computer Science programme at Mar Thoma College of Science &Technology, Chadayamangalam, Kollam (Unaided) with effect from the academic year 2025-2026, as per the existing norms.

Accordingly, the Secretary, Mar Thoma College of Science &Technology, Chadayamangalam, Kollam, vide paper read as (6) above, had remitted the fee for closure of course of study and Suspension of course of study.

Sanction has, therefore, been accorded by the Registrar, for the suspension of M.Sc Computer Science programme for the academic year 2025-'26 and for closure of M.Sc Electronics programme from the academic year 2025-2026 in Mar Thoma College of Science &Technology, Chadayamangalam, Kollam (Unaided), subject to the following conditions.

- That the Educational Agency, considering the future requirement of the students who had undergone studies till the closure of the mentioned programme, shall make arrangements to maintain academic records of the students of the programme.
- As per Statute 16, Chapter 24 of KUFS, 1977, the Educational Agency of the college



shall do the needful to facilitate the examinations for all their candidates for the above mentioned programmes.
