ORDER

The eligibility criteria for admission to Career-related First Degree Programmes in Computer Science (B.Sc) and Computer Application (BCA) under CBCS System was modified vide U.O read as (I) above.

The Academic Council vide paper read as (2) above, considered the requests of candidates who had completed 12th standard in Science stream with Informatics Practices (IP) instead of Mathematics as optional subject for admission to BCA Degree programmes and resolved that 'the candidates who completed 12th Std in Science stream are eligible for admission to the Career-related First Degree Programme in Computer Applications (BCA) under CBCS System and resolved that the feasibility of extending this benefit to the students of non-science streams be considered by the Board'.

The Board of Studies in Computer Science (UG) vide paper read as (3) above, recommended to modify the eligibility criteria of BCA as follows :

"A pass in Higher Secondary or any other examination recognized as equivalent thereto by the University of Kerala with Computer Science/ Computer Applications/ Mathematics/ Informatics practices (IP) as one of the optional subjects".



Index Marks calculation

"Total marks in Higher Secondary + Highest marks for Computer Science / Computer Applications / Mathematics / Informatics Practices"

The Dean, Faculty of Applied Sciences and Technology vide paper read as (4) above, endorsed the recommendations of the Board of Studies in Computer Science (UG).

Sanction has been accorded by the Vice-Chancellor, subject to reporting to the Academic Council, to approve the above amendments in the eligibility criteria for admission to the Career related First Degree Programme in Computer Applications (BCA) under CBCS System, as recommended by the Board of Studies in Computer Science (UG) and as endorsed by the Dean, Faculty of Applied Sciences and Technology.

The eligibility criteria stated in the UO read as (1) above stands modified to this extent.
