## ORDER

The Vice-Chancellor had suggested that in view of the considerable time and effort on the part of the University to administer the Endowment/Chair instituted at the University, a minimum amount of Rs.5,00,000/- (Rupees Five Lakh only) and Rs.5,00,000/- (Rupees Five Crore only) respectively, will be appropriate for the purpose.

The Syndicate, in exercise of the powers conferred in the Kerala University Act, 1974, Section 23 Clause xxii, at its meeting vide paper (2) read above, had resolved to implement the proposal of the Vice-Chancellor.

Sanction has, therefore, been accorded by the Vice-Chancellor to implement the Corpus Fund minimum amount of **Rs.5,00,000/-** (Rupees Five Lakh only) for instituting an **Endowment** at the University henceforth and **Rs.5,00,000/-** (Rupees Five Crore only) for constituting a **Chair**.

The University Order shall not apply for the existing endowments/chairs/lectures already in vogue till date as per earlier Syndicate decision read as paper (1) above.
