Accordingly all the above mentioned colleges had fulfilled the procedural formalities for suspension of courses as prescribed by the University.

Sanction has therefore been, accorded by the Vice Chancellor, for the suspension of newly sanctioned UG programmes in following colleges as during 2021-'22 academic year.
