B Sc examination section has vide note read as paper (1) above sought Clarification regarding whether eligible gracemarks for NCC cadets may be awarded for one additional chance including improvement /betterment and also for papers of the supplementary examinations in the next immediate chance just as done in the case of awarding gracemarks for performance in Sports and Games ,Arts and NSS, .Another point that has been observed as omitted in the existing U.O is that it is not clarified in the U.O that the benefit of gracemarks is awarded for NCC cadets who are regular bonafide students of this University just as clarified in the case of awarding gracemarks for NSS, Sports and Games and Arts.

The above two points were placed before the Standing committee of the Syndicate on students services for consideration, which vide (item No:3) recommended to incorporate the above two guidelines in the existing U.O.The Syndicate vide paper read as (4) above resolved to approve the above recommendation .

Sanction has therefore been accorded by the Vice- chancellor to incorporate the following guide lines in the U.O read as (2) above.

- 1. Eligible gracemarks for NCC cadets shall be awarded for one additional chance including improvement /betterment and also for papers of the supplementary examinations in the next immediate chance.**
- 2. The benefit of gracemarks shall be awarded for NCC cadets who are regular bonafide students of this University.**

The U.O read as paper (2) stands modified to this extent.
