Payment of UGC Fellowship Schemes – last date of submission of application for extension of fellowship through University for the period ending 30.06.2016 – intimating of reg.

As per the directions received from UGC, vide letter referred as (1) above, it is hereby informed that all the research scholars who are availing fellowship under various schemes of UGC through University shall claim such fellowship amount through the University upto the period ending 30.06.2016 only. This condition shall apply even if sanction has already been accorded for periods beyond 01.07.2016. The Circular referred as (2) above stands modified accordingly.

The payment of fellowship will be disbursed to the candidates by the UGC under Direct Benefit Transfer Scheme with effect from 01.07.2016. Hence the research scholars who are availing their UGC fellowship through University and who have not yet submitted their application for extension of fellowship shall submit the same for the period ending 30.06.2016 on or before 18.06.2016 since the last date of endorsement for sanction of fellowship shall be on or before 30.06.2016. The bills shall also be submitted and claimed on or before 20.07.2016 positively. No claims shall be admitted after this date. The Circular referred as (3) above stands modified accordingly.
