### **Terms and Conditions**

1. The Bidder should be a manufacturer or their dealer specifically authorized by the manufacturer to quote on their behalf for this tender as per Manufacturer Authorization Form and Indian agents of foreign principals, if any. Equipment must be of the most recent series/models incorporating the latest improvements in design. The models should be in successful operation for at least one year as on date of Bid Opening.
2. Original Equipment Manufacturer Certificate or their Authorized Dealer Certificate shall be furnished.
3. Incomplete & conditional tenders and tenders received after the due date will be summarily rejected without assigning any reasons thereof.
4. The price should be inclusive of all taxes, duties, transportation, installation, etc. Nothing extra will be paid in addition to the quoted rate.
5. **Validity of tender:** Tender submitted shall remain valid at least for 180 days from the date of opening the tender. Validity beyond six months from the date of opening of the tender shall be by mutual consent.
6. **Delivery and installation:** Proposed delivery schedule should be mentioned clearly. Delivery and installation should be made at University College of Engineering, University of Kerala, Kariavattom campus, Trivandrum - 695581, without any extra cost. Complete installation, testing and demonstration of the system and day-to-day maintenance are to be provided at site.
7. **Service Facility:** Supplier should mention their details of service setup and manpower in Kerala, who are responsible for after sales support.
8. The model number, make and a printed literature of the product shall submit positively.
9. In case of any dispute, the decision of the University authority shall be final.
10. The undersigned reserves the right to reject any or all of the Tenders received without assigning any reason thereof.
11. Every Tenderer should submit a Tender Fee of Rs. 1,770/-.



12. Every Tenderer should submit an Earnest Money Deposit (EMD) of Rs. 8,000/-.

13. All the MSMEs with Udyog Aadhar Registration or any other body specified by the Ministry of Micro, Small & Medium Enterprises working within the state of Kerala will be exempted from the payment of Tender Fee and Earnest Money Deposit. Other firms not having MSME with Udyog Aadhar Registration and the firms outside Kerala should remit the Tender Fee and Earnest Money Deposit (EMD).

14. Full payment will be made only after satisfactory completion of the supply & installation of the items at the University College of Engineering, University of Kerala, Kariavattom campus, Trivandrum - 695581 and advance payment will not be allowed under any circumstances.

15. No part payment shall be made.

16. Compliance Statement should be submitted that includes all parameters as in specification.

17. Complaints if any with the items supplied should be rectified/replaced to the satisfaction of the College by the suppliers at their own cost.

18. Detailed Financial Bids should be separately submitted (in pdf format).

19. Payment will be made only after the items are actually supplied, installed, verified and taken into stock. The Bidder will produce stamped pre-receipted invoices for the release of the payment.

20. All the documents mentioned shall be submitted without fail.

21. All the documents must be typed & clear.

22. **Period of Completion:-** The supply & installation shall be completed at the proposed site within a period of 15 days from the date of placing the Supply Order.

23. The Tender shall be submitted in two Bids viz. Technical Bid and Financial Bid. Only those qualified in the Technical Bid will be eligible for participating in the the Financial Bid.

24. General rules relating to purchase of materials/equipment will also applicable to this Tender.

25. **Performance Security** : If work is awarded, a Performance Security equal to 5% of the contact value shall be furnished by the bidder. The Performance Security will be forfeited, if the firm fails to abide the terms and conditions of the tender and subsequent execution of the work/warranty liability. It will be released after the warranty period.

26. Catalogue of the quoted equipment is mandatory.

27. Only one model can be quoted in the Tender.

28. During the warranty period, the supplier shall provide periodic maintenance of the UPS and Batteries at an intervals of every six months.
