Kariavattom Campus, for regular maintenance and prompt repair services.

#### Scope of Work:

The CAMC covers the following services for the UPS systems:

- 1. Preventive maintenance on a quarterly basis.
- 2. Corrective maintenance as needed.
- 3. Replacement of faulty components (if required).
- 4. Ensuring optimal performance of the UPS systems.
- 5. Availability of technical support during emergencies.
- 6. Minimum response time for breakdown calls: The vendor must respond within 2-4 hours for critical breakdowns and within 24 hours for non-urgent repairs.
- 7. Provision for a standby UPS during maintenance or repairs to ensure uninterrupted power supply

#### Eligibility Criteria:

- 1. The vendor must have a minimum of 3 years' experience in providing AMC services for UPS systems in educational institutions or similar organizations.
- 2. The vendor should have skilled personnel capable of handling maintenance and repairs for UPS systems of various brands and capacities.

#### **Quotation Submission:**

Interested vendors are requested to submit sealed quotations with the following details:

- 1. Itemized quotation for AMC charges, including labor and spare parts costs.
- 2. Validity period of the quoted rates.
- 3. Company profile and experience certificates, if any.
- 4. References of previous similar contracts, if applicable.

- 1. The contract period will be for **one year** from the date of agreement, subject to satisfactory performance.
- 2. Payment will be made on a **quarterly/half-yearly/yearly basis** upon submission of maintenance reports and invoices.
- 3. Any **damage or replacement charges** should be mentioned separately.
- 4. The University reserves the right to accept or reject any quotation without assigning any reason.
