3. General Tender Terms & Conditions for technical verification

- Bidders who are blacklisted by State / Central Government Departments and Organizations are not eligible to participate in this tender and such bids will be summarily rejected.**
- The bidders from outside Kerala are not eligible to participate in this tender and such bids will be summarily rejected.**
- Compliance Statement should be submitted separately that includes all parameters, as in specification.**
- Detailed equipment Data sheet/Technical Brochure/Technical Specification/Technical Bid should be submitted.**



5. **All items**, except lights, **should have a warranty period of 2 years**. **Light fittings (including LED Tubes and Bulbs)** should have a minimum warranty period of **one year**.

6. **Group wise evaluation** is applicable to this tender.

7. The lowest successful bidder **should be obliged to supply the material of the Make/Manufacturer mentioned in the supply order**, as per the instruction of the University.

8. The Tender Form Fee and EMD will be made mandatory for all the bidders participating in this tender, as the tender is invited on contract basis.

9. The successful bidder who is awarded the contract shall furnish an undertaking that the equipment to be supplied strictly adhering to the specifications and standards specified in the Tender Document.

10. The successful bidder who is awarded the contract shall submit a Performance Security equivalent to 5% of the total value of the contract rounded to the nearest rupee.

11. The successful bidder shall submit an MoU in Stamp paper worth Rs. 200/- for executing the contract.

5. Terms and conditions

1. Withdrawal from the tender after it is accepted or failure to supply the items within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offerers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the University of Kerala reserves also the right to remove the defaulter's name from the list of University suppliers permanently or for a specified number of years.
2. No representation for enhancement of price once accepted will be considered.
3. Payments will be made only after the items are actually verified and taken to stock. The bidder will produce stamped pre-receipted invoices for the release of the payment.
4. Special conditions, if any, printed on the bid sheets of the tenderer or attached with the tender, will not be applicable to the contract, unless they are explicitly accepted in writing by the purchasers.



5. The Bidder shall quote price in clear terms. The rates quoted must be inclusive of all taxes, cost of supply at site, warranty etc...
6. The price should be quoted only in Indian rupees. The bid shall be typed and signed by the bidder.
7. All the documents mentioned shall be submitted without fail.
8. All the documents must be typed and clear.
9. Detailed specifications of the items along with to enter the unit price of each item are available within the BOQ appended to the tender notification.
10. Group Wise Technical/Financial Evaluation is applicable to this tender.
11. **Validity:-** The Bid will be valid for 180 days from its date of opening. Further extension can be done by mutual consent.
12. **Delivery :-** The item should be delivered at proposed site as mentioned in the Supply Orders.
13. **Period of Completion:-** The supply shall be completed at the proposed site within a period 7 days from date of placing the Supply Orders.
14. **Payment: -** The Full payment will be made only after successful completion of the supply of items at the proposed site mentioned in the Supply Order and advance payment will not be allowed under any circumstances. No part payments shall be made.
15. Complaints if any with the items supplied should be rectified/replaced to the satisfaction of the University by the suppliers at their own cost.
16. The undersigned reserves the right to reject or accept any or all the tenders received fully or partly without assigning any reason thereof.
17. General rules relating to purchase of materials/equipment will also applicable to this tender.
