The cost of tender form and Earnest Money Deposit (EMD) should be submitted as separate Demand Drafts (DD) issued from a Nationalised and Scheduled Commercial Bank, drawn in favour of the **Finance Officer, University of Kerala, payable at State Bank of India, Kerala University Office Campus (KUOC) Branch (IFS Code : SBIN0070292)**, as described below :

Terms and conditions

1. The Tenderer shall quote price in clear terms. The rates quoted must be inclusive of all charges such as packing, forwarding, freight, loading/unloading/handling or installation charges and Government duties leviable, if any.
2. The rates quoted in Tenders should be only in Indian currency. Tenders in any other currency are liable to rejection. The Tender shall be typed and signed by the Tenderer.
3. All the documents mentioned shall be submitted without fail. Tenders which are not in the prescribed form are liable to be rejected.
4. Sample should be attached along with the Tender documents.
5. Matter to be printed should be collected from the Kerala University Press. Finished item should be delivered at the Kerala University Press, SH Campus, Palayam within 10 days from the date of receipt of approved matter.
6. Specimen copy available at Press Office for verification purpose.
7. The Full payment will be made (after deducting TDS amount) only after successful completion of the supply of items and advance payment will not be allowed under any circumstances.
8. Complaints if any with the items supplied should be rectified/replaced to the satisfaction of the University by the suppliers at their own cost.
9. The undersigned reserves the right to reject or accept any or all the tenders received fully or partly without assigning any reason thereof.
10. Separate DD towards the cost of the tender form(₹1,180/-) and the EMD(₹4,828/-) should be submitted.
11. All the MSMEs with Udyog Aadhar registration or any other body specified by the Ministry of Micro, Small and Medium Enterprises working within the state of Kerala will be exempted from the payment of Tender fee and Earnest Money Deposit. Copy of the Registration Certificate may be enclosed with the tender for reference.
12. An amount, equal to 5% of contract value as Performance Security (preferably as DD) shall be paid by the successful Tenderer before the receipt of Work Order letter from Kerala University Press. The Performance Security will be forfeited, if the firm fail to abide the terms and conditions of the tender and subsequent execution of the work. The said amount will be released on successful completion of printing and supply of Annual Planner 2026.

The sealed tenders along with the Tender document, separate DD towards the cost of the Tender form and the EMD should be addressed to "**The Superintendent(i/c), Kerala University Press, University of Kerala, Thiruvananthapuram – 34**", in a sealed cover with the Tender number and name – "**Tender for the printing and supply of Annual Planner 2026**" duly superscribed on the cover. The last date of receipt of tenders is at 3.00 PM on 28.01.2026. The tenders will be opened at the office of the University Press, Palayam Thiruvananthapuram on 3.30 PM on the same day in the presence of vendors then present.
