Terms and Conditions

1. The vendor shall quote price in clear terms. The rates quoted must be inclusive of all taxes, cost of supply at site, warranty and installation charges etc. The price should be quoted only in Indian rupees.
2. Intending vendors should send their quotations so as to reach the officer mentioned in the quotation notice, on or before the due date and time noted therein. No quotation received after the specified date and time will be accepted on any account.
3. The quotations will be opened on the appointed day and time in the office of the Registrar, in the presence of such of those vendors or their nominees who may be present at that time.
4. Complaints with the items supplied should be rectified/replaced to the satisfaction of the University by the suppliers at their own cost.
5. The vendors shall undertake to supply materials according to the specifications (appended as Annexure A)
6. No representation for enhancement of rates once accepted will be considered.
7. Validity:-The Bid will be valid for 90 days from its date of opening. Further extension can be done by mutual consent.
8. Delivery:-The item should be delivered at the SH Campus, Palayam.
9. Installation and Commissioning:-The items shall be installed and commissioned in the Academic Ac A1 Section of the University of Kerala, SH Campus.
10. Period of Completion:-The work shall be completed within a period 45 days from date of issue of supply order.
11. Payment: - The University will release the payment only after inspecting the work and satisfy that the items are supplied as per the requirements and on the basis of actual quantity executed. The payment will be made after successful completion of the supply on producing invoice in triplicate. The final bill shall be based on the actual quantity of supply made.
12. Warranty/Guarantee: The supplier shall guarantee to repair/replace the items or its part -if found defective within the warranty (Defect Liability) period of minimum 1 year.
13. The supplier shall guarantee to repair/replace the items or its part -if found defective within the warranty (Defect Liability) period of 1 year for the items, the warranty of which are not mentioned Estimate. For other items supplier shall replace the item within the warranty period mentioned in Specification/estimate.
14. The entire expenditure for repair/ replaces the item in this regard shall be borne by the supplier. Warranty shall be applicable for entire item
15. In case of dispute arises, the decision of University authority shall be final.
