### Terms and Conditions

- The quotations shall be accompanied with an EMD of ₹50,000/- (Rupees Fifty Thousand only) by Demand Draft drawn in favour of the Finance Officer, University of Kerala.
- The successful bidder shall remit an amount of ₹75,000/- (Rupees Seventy Five Thousand only) as Security Deposit to Kerala University Fund, thereafter and confirm the acceptance of the offer.
- The contractor shall ensure that the waste papers and waste materials are removed from the place where it is kept at his own expenses.
- The contractor shall pay sales tax at the rate envisaged by the Government.
- The waste papers and waste materials shall be removed after remitting the amount in advance to Kerala University Fund.
- The contractor shall submit the details showing empty weight of the vehicle, vehicle type and



date, for availing gate pass.

- The contractor shall remit the payment to KUF on the same day of issuance of gatepass and shall submit the challan receipt in original to the section concerned, in the following format:
