

Rules for the award of University Merit Scholarships for the  
Four Year Degree Course in Engineering

1. There shall be Thirty (30) Merit Scholarships of the value of Rs.2,500/- (Rupees Two thousand and five hundred only) each per annum.
2. The subject wise distribution of the scholarship shall be as follows:
  1. Civil 3
  2. Mechanical 2
  3. Mechanical Stream – Production Engineering 2
  4. Mechanical Stream – Automobile Engineering 2
  5. Mechanical Stream – Industrial Engineering 2
  6. Chemical Engineering 2
  7. Bio-Technology & Bio Chemical Engineering 2
  8. Electrical & Electronics Engineering 3
  9. Electronics & Communication Engineering 3
  10. Applied Electronics & Instrumentation 2
  11. Computer Science & Engineering 3
  12. Information Technology 2
  13. B.Arch 2
3. These scholarships shall be awarded annually by the Syndicate on the basis of merit as judged by the percentage of the total marks secured by the students of the HSE/VHSE/CBSE/ISC Examination held immediately before the date of their admission to the Colleges.
4. The Scholarships are tenable for a period of four (4) years. (5 years for B.Arch Degree Course).
5. The Scholarships shall be awarded only to students who pass the HSE/VHSE/CBSE/ISC examination at the first attempt and who secure not less than 60% marks at the HSE/VHSE/CBSE/ISC Examination.

6. If the scholarship awarded to a student falls vacant, the vacant scholarship shall be awarded to the candidate next in the rank in the subject concerned, as per rules.
7. In the event of there being no candidate eligible for the award in any one of more subjects in a year, the award of such scholarships shall be decided by the Syndicate.
8. All the candidates having the same marks at the +2 level examination shall be considered for the scholarship irrespective of their performance at the X level examination.
9. The Principals of the Engineering colleges shall be drawing officers for disbursement of the above scholarships. The annual value of the scholarships shall be paid on a quarterly basis in advance to the principals concerned. The Principals shall forward to this office the payee's receipts for the first quarter along with the bills for the second quarter and so on. The bills for the four quarters shall be forwarded by the principals and payments made to them by the University in the months of June, September, December and March every year. The Principals shall retain the amounts with them and make payments in arrears to the students at the close of each quarter. It shall be the responsibility of the Principals to see that the disbursement are made strictly in accordance with the rules. Any unspent balance left with the Principals at the end of each academic year shall be remitted to the Kerala University Fund and the details of remittance (viz. Draft/Chalan No., date and amount) reported to the University immediately thereafter.
10. Students who belong to the Kerala State and are studying in any of the Colleges affiliated to the University of Kerala immediately after passing the qualifying examination are eligible for the awards.
11. The scholarships shall not be held concurrently with any other scholarships except Welfare Scholarships offered by State/Central Government. The continuance of the scholarship shall depend upon the satisfactory progress and conduct of the holders thereof.
12. The scholarships shall not be held for more than one year in the same class and shall be discontinued in the event of failure at a University Examination.
13. The scholarships may be held along with fee concessions, if any, enjoyed by the holders.
14. Any change in these Rules shall be made by the Syndicate.
