ORDER

The Board of Studies in Law (Pass) vide paper read as (1) above considered the preparation of norms for inter-collegiate transfer of LL. B students and approved the norms. The Faculty vide paper read as (2) above endorsed the same. The Academic Council vide paper read as (3) above resolved to approve the same with some modifications.

The norms for inter-collegiate transfer of students of LL. B Degree Course, as approved by the Academic Council, are as follows:

1. *Under no circumstance, inter-university transfer is permitted.*
2. *Transfer from private & self-financing colleges to Govt. college is also not permitted.*
3. *Transfer can only be to a college offering same course, scheme and syllabus as that of the parent college.*
4. *Category of seat in both the colleges be identical, i.e, transfer is permitted only between merit to merit quota and management to management quota.*
5. *Transfer may be permitted in the third to fifth semesters in the five year stream and second to fourth semesters in the three year stream.*
6. *Transfer shall be made purely on the basis of vacancies.*
7. *Both the principals should consent for the transfer.*
8. *Transfer shall be effected only on one or more of the following valid reasons with supporting documents.*
 - 1) *Death of the supporting parent or guardian.*
 - 2) *Change of residence due to transfer of parent or guardian.*
 - 3) *Acute health related issues of student /parent/guardian.*
9. *The student shall not be under enquiry for misconduct or facing any disciplinary action in the parent institution. A certificate to that effect from the principal must be attached along with the application.*
10. *Transfer shall be effected within the first month of commencement of the semester to which admission by transfer is sought.*
11. *If more than one application for a particular vacancy is received the transfer shall be given based on the academic merit of the student in the previous semesters.*
12. *No change of optional subject is permitted under any circumstance.*
