ORDER

Applications were received from the candidates who had completed Career-related First Degree Programme in Botany and Biotechnology, under CBCS System 2(a) to issue Special Certificate stating that Career-related First Degree Programme in Botany and Biotechnology, under CBCS System, is equivalent to the First Degree Programme in Botany and Career-related First Degree Programme in Biotechnology under CBCS System.

The Chairman, Board of Studies in Botany (Pass) remarked that the syllabus of First Degree Programme in Botany under CBCS System of University of Kerala is having about 90% similarity to the Core course - Botany of Career-related First Degree Programme in Botany and Biotechnology of University of Kerala. And recommended that equivalency certificate stating that Career-related First Degree Programme in Botany and Biotechnology is equivalent to First Degree Programme in Botany may be given to the applicant for job purpose.

The Chairman, Board of Studies in Biotechnology (Pass) recommended that a special certificate may be issued to the candidate stating that Career-related First Degree Programme in Botany and Biotechnology is equivalent to Career-related First Degree Programme in Biotechnology, for Job purpose.

The Deans of Faculty of Applied Sciences and Technology and Faculty of Science endorsed the recommendations of the Chairmen, Boards of Studies in Biotechnology (Pass) and Botany (Pass).

The Standing Committee of the Academic Council vide paper read as (4) above, recommended that the Career-related First Degree Programme in Botany and Biotechnology under CBCS System is equivalent to Career-related First Degree Programme in Biotechnology under CBCS System and the First Degree Programme in Botany under CBCS System for job purpose, subject to reporting to the Academic Council.
