**ORDER**

The Regulations relating to First Degree Programmes under CBCS System to be followed by the Affiliated Colleges and Centres of the University from 2013 admissions was issued vide paper read as (1) above.

As per the Regulations, the marks for Continuous Evaluation (CE) was consolidated by adding the marks of attendance, seminar/assignments and test papers. Later, the marks for attendance in Continuous Evaluation (CE) and minimum marks prescribed for CE were excluded w.e.f. 2020 admissions. Accordingly, Clause 12.16 read as “those who fail in the CE (i.e. those who fail to secure a minimum of ‘E’ Grade) will have one chance to improve the same (except the marks for attendance) along with next regular batch of students.” was modified as **“those who fail to secure a pass minimum of 35% (E Grade) for a course will have one chance to improve CE marks for the course”** vide U.O read as (2) above.

The Standing Committee of the Academic Council, vide paper read as (3) above, considered the request of candidates of First Degree Programmes under CBCS System, who secured a pass in CE, to grant additional chance to improve Continuous Evaluation (CE) and recommended to go by the Regulations permitting reappearance for Continuous Evaluation (CE) for failed candidates only and referred the matter to the Academic Council, for taking a final decision.

The Academic Council, vide paper read as (4) above, resolved to approve the recommendations of the Standing Committee of the Academic Council to follow the Regulations permitting re-appearance for Continuous Evaluation (CE) for First Degree Programmes under CBCS System, for failed candidates only and further resolved to retain pass minimum for CE component and replace the word, “improve” with “re-appear”.

Orders are issued accordingly.
