**ORDER**

The University Grants Commission (Minimum Qualifications for appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) Regulations 2010 referred as (1) above, was adopted and implemented by the University along with the 2<sup>nd</sup> Amendment brought in by the UGC vide paper referred as (2) & (3) above.

The Hon'ble High Court in the judgment vide paper referred as (4) above has directed to comply with UGC Regulations 2010 in view of its adoption by the State of Kerala with effect from 18.09.2010 .

The Syndicate vide paper read as (5) above has fixed the norms and procedures for the appointment of Principals in Private/Aided affiliated Colleges.

In the Interim Order referred as paper (8) above, the Hon'ble High Court has directed the University to issue consolidated instructions to all the Aided Colleges regarding the modalities involving the Selection Procedure for the appointment to the post of Principals under Clause 4.2.0 of the UGC Regulations 2010 and for the placement of teachers under the said Regulations. The Standing Committee of the Syndicate on T&NT Staff of Private Colleges held on 17.02.2017 has recommended the norms and procedures to be adhered to in the process of Selection of Principals both by promotion and direct Recruitment, Placement/Promotion of teachers and the documents to be forwarded along with the proposals for approval.

The Vice Chancellor in exercise of the powers vested upon him under Section 10(13) of Kerala University Act 1974, approved the recommendations of the Standing Committee regarding the norms and procedures to be adhered to in the process of Selection of Principals, Placement/Promotion of teachers and the documents to be forwarded along with the proposal for approval, appended as Appendix I , II & Annexure I to this U.O subject to reporting to the Syndicate.
